- 1. SPONSOR:** The sponsor of this Scoop Creamier Grand Sweeps Sweepstakes (the “Promotion”) is Tillamook County Creamery Association, at 4185 Highway 101 North, Tillamook, Oregon 97141 (“Sponsor”).

This Promotion is NOT sponsored, endorsed, or administered by, or associated with, Instagram.

- 2. ELIGIBILITY:** This Promotion is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry and who can provide proof of U.S. residency and age. Residents of U.S. territories and possessions, U.S. military installations in foreign countries, and all locations not physically located within the continental United States are excluded from this Promotion. Past and present employees, officers, directors, and agents of Sponsor and any of its affiliates, prize suppliers, distributors, advertising and promotion agencies, and other companies involved in the development or administration of this Promotion, as well as the immediate family members of such employees, officers, directors, and agents (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in the same household (whether or not related) with such employees, officers, directors, and agents, are not eligible to enter or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. This Promotion is void where prohibited, restricted or taxed by law. - 3. TIMING:**

- (a) SWEEPSTAKES ENTRY PERIOD:** The Promotion entry period begins on Monday, May 9, 2022 at 12:00:01AM Pacific Daylight Time (“PDT”) and ends on Friday, July 29,

2022 at 11:59:59PM PDT (the "Sweepstakes Period"). Sponsor's computer, or its third-party service provider's computer, is the official timekeeping device for the Promotion.

(b) **DRAWING:** One (1) potential winner will be chosen through a random drawing (as discussed below) on or about Saturday, July 30, 2022. The potential winner will be randomly drawn from all eligible entries received during the Sweepstakes Period. See information regarding timing for prize notification below.

By entering the Promotion, you will automatically be signed up for both the Partnership for Creamier Ice Cream (PCIC) and Tillamook County Creamery Association email lists. You may unsubscribe from one or both email lists at any time using the unsubscribe method provided in marketing emails we send you. Limit: one (1) entry per person. Each entrant can only use one (1) email address to enter. Any attempt by a participant to enter the Promotion more than once by using multiple/different email addresses or identities or any other method will disqualify that participant. Use of any scripts, macros, bots or automatic means to submit entries is prohibited and will result in disqualification. Entries containing false or fraudulent information will be disqualified. Sponsor has no obligation to notify the participant of the disqualified entry.

In the event of a dispute as to the person associated with any entry, the authorized account holder of the email address used to enter will be deemed the participant. With respect to email addresses, the "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address. The potential winner may be required to show proof of being the authorized account holder.

Only entries received by the end of the Sweepstakes Period will be eligible for the prize. All entries received after the end of the Sweepstakes Period will be void and will not be eligible to win. Sponsor will not verify receipt of entries, and proof of submission will not be deemed proof of receipt by Sponsor. Entries are automatically null and void if not obtained through the

authorized channels or if any part is late, lost, stolen, incomplete, illegible, unintelligible, invalid, damaged, misdirected, or contains typographical or other errors. Sponsor is not responsible or liable in any way for such entries or errors. Sponsor has no obligation to notify the participant of the disqualified entry.

Unless required by law, Sponsor is not required to review or respond to any correspondence received from a participant regarding the Promotion.

4. DRAWING & NOTIFICATION:

(a) **WINNER SELECTION.** There will only be one (1) prize winner. One entry will be selected via a random drawing on or about Saturday, July 30, 2022, drawn from all eligible entries received during the Sweepstakes Period. The result of the drawing, and the decisions of Sponsor and its third party service provider administering the Promotion, are final and binding in all respects.

(b) **WINNER NOTIFICATION AND ANNOUNCEMENT.** Receiving the prize is contingent upon compliance with these Official Rules. The potential winner will be notified by email on or about August 1, 2022. Once the potential winner is contacted via email, the potential winner must respond to claim the prize and provide the requested information (which could include full name, address, phone number, proof of age, and proof of residency) within three (3) days from the time Sponsor (or a third party administrator) sends the win notification via email. - **Airfare for two (2) for a coach class roundtrip flight to be arranged by Sponsor from a major commercial airport near winner’s residence to Portland, Oregon arriving on Friday 8/19/22 and departing Sunday 8/21/22. (Approximate Retail Value (“ARV”): ~\$1,500. Exact value will depend on winner’s location.) Winner is responsible for traveling to and from a major commercial airport near winner’s residence.**
- **One (1) 4-door sedan car rental from PDX Portland Airport, from Friday 8/19/22 to Sunday 8/21/22, to be arranged by Sponsor (gas included) (ARV: \$900)**
- **Two (2) nights’ stay at the River Cabaan Airbnb (one room) located in Tillamook, OR (ARV: \$1,024)**
- **Exclusive ice cream experience for two (2) at the Tillamook Creamery on Saturday 8/20/22 (ARV: \$80)**
- **Exclusive homemade dinner experience by Chef Josh from the Tillamook Creamery for two (2) at the River Cabaan Airbnb on Saturday 8/20/22, including appetizer, entrée, and ice cream flight (ARV: \$250)**
- **Meal stipend for two (2) for the weekend of August 19-21, 2022 (ARV: \$800)**
- **Fridge at the River Cabaan Airbnb to be filled with 3 48oz Tillamook Ice Cream cartons and Tillamook snack products (ARV: \$50)**

The total ARV of all elements of the prize combined is ~\$4,604 (not including shipping).

(b) **PRIZE DELIVERY:** Once Sponsor has determined that the winner meets all eligibility and other requirements in these Official Rules, Sponsor will coordinate prize delivery with the winner directly. Sponsor will send the prize information and prize elements (airplane tickets, rental car information, River Cabaan Airbnb confirmation, and stipend) to winner’s specified email address. Sponsor will not be responsible or liable for a lost, stolen, or damaged prize once emailed by Sponsor to the email address provided by the winner.

(c) **PRIZE CONDITIONS:**

(i) **ONE PRIZE ONLY:** Only one (1) prize will be awarded. The prize must be used on the dates set forth above and completed by August 21, 2022.

(ii) **TRAVEL COMPANION:** winner and winner’s travel companion must travel on the same itinerary. If winner elects to travel or partake in the prize without a travel companion, no additional compensation will be awarded. Winner’s travel companion must be at least eighteen (18) years of age at the time the prize is used; provided, however, that winner’s travel companion may be under eighteen if accompanied by an adult who is the parent or legal guardian of the travel companion.

Winner agrees that Sponsor may alter winner's Name and Likeness and may combine winner's Name and Likeness with other materials and information (including without limitation, text, data, images, photographs, illustration animation and graphics, or video or audio segments of any nature, in any media or embodiment, now known or hereafter developed). Winner accepts and acknowledges that

Sponsor shall not be obligated to use winner's Name and Likeness, and Sponsor shall not incur any liability whatsoever to the extent Sponsor chooses to refrain from any exploitation of its rights hereunder.

Note you will have to unsubscribe from each mailing list separately. Unless otherwise set forth in these Official Rules, personal information collected through entry into the Promotion will be used in accordance with Sponsor's privacy notice at: <https://www.tillamook.com/privacy-policy.html>

- 9.
