

Nathan Wallis ticket draw

Terms and Conditions (“Terms”)

1. The promoter of the competition is nib NZ Limited (“nib”), 48 Shortland Street, Auckland 1010.
2. This competition is open to individuals who submit their parenting stories on the nib New Zealand Facebook page between 26 July and 10 August 2021 (“competition period”). Entries may also include images. Entrants who are selected as one of the winners must consent to their story and images (if included in the entry) being shared on the nib New Zealand Facebook page.
3. By submitting an entry, entrants agree to these Terms. Any entry not complying with these Terms is invalid.
4. Entries must be received during the competition period.
5. Entries must not be obscene, defamatory, libelous, threatening, harassing, hateful, racially or ethnically offensive, or encouraging of conduct that would be considered a criminal offence, gives rise to civil liability, or violate any law. This competition is open to 18+ year old NZ residents only.
6. This competition is not open to any employees (or their immediate family members) of nib or its related companies.
7. Valid entries from eligible entrants will automatically go into the draw. Four winners will be drawn on 15 August 2021. Only one entry per person will be eligible to go in the draw. The Prize winners will be selected at random from the valid entries.
8. The prize available is a double pass to a Nathan Wallis event only (“Prize”). The Prize cannot be refunded or redeemed for cash.
9. nib will contact each winner on or about 15 August 2021. If the winner does not wish to accept the Prize or cannot be contacted or does not respond within 24hrs of notification, that Prize will be forfeited and awarded to an alternate winner drawn from the remaining valid entries.
10. Any expenses (including but not limited to travel, transport, food, beverage and making changes to any travel arrangements) incurred in relation to accepting or using the Prize (or part of the Prize) are the responsibility of the winner.
11. Due to this being a promotion directly related to a specific event, if the event is cancelled for any reason, there will not be an alternative Prize. However, if the event is postponed due to COVID restrictions or related concerns, then nib will use all reasonable endeavours to re-arrange the Prize to another Nathan Wallis event.

To the maximum extent permitted by law, nib will not be liable for any loss or damage whatsoever (including but not limited to indirect or consequential loss) or for any personal injury or death incurred or sustained as a direct or indirect result of winning or using the Prize. nib will not be liable for any loss or damage caused directly or indirectly by any events which are beyond our control including, but not limited to war, civil disturbance, epidemic, fire, floods, acts of God or acts of government.

13. Entrants' personal information (including images submitted in the entry) will be collected by or on behalf of nib to enable it to administer the competition and publicise the winner. The personal information of the winner may be provided to third parties for the purpose of processing and conducting the competition. By entering this competition, entrants consent to the use of their personal information as described. Entrants may contact nib at the address given above to request access to, or correction of, any of their personal information that is collected and held by nib. If an entrant does not provide accurate personal information nib may determine that they are not eligible to win a prize. All entries become the property of nib.
