

# Cat® Hoses for Brisbane - “Cat Hoses built in under 60 minutes ” Promotion

## Promotion Overview

1. Subject to these terms and conditions, Hastings Deering (Australia) Limited (Hastings Deering) is offering Brisbane Business Centre customers a parts.cat.com (**PCC**) credit equal to the purchase price (up to a maximum of two (2) Qualifying Permanent Crimp Cat® Hose Assembly Products for a Cat machine with an applicable Cat part number per Eligible Order (**Qualifying Products**)) when the Order is completed in more than one (1) hour from the time the order is placed (**Promotion**).
2. The Promotion applies to Eligible Orders placed between **1 April 2026 and 31 August 2026**, inclusive.

## Eligibility & Redemption

3. This Promotion is only available to Brisbane Business Centre Customers who make an Eligible Order within the Promotion Period.
4. An **Eligible Order** is an order:
  - a. that consists of:
    - i. only Qualifying Product(s); and
    - ii. a maximum of two (2) Qualifying Products;
  - b. made from 1 April 2026 to 31 August 2026 (inclusive) between the hours of 6:00am to 5:00pm AEST, seven (7) days a week (**Promotion Period**); and
  - c. made at the **Hastings Deering Brisbane Business Centre** by either:

6. If the Eligible Order is completed by Hastings Deering more than one (1) hour from the time the Eligible Order is placed, then the Customer will be entitled to a PCC credit equal to the purchase price of the Qualifying Permanent Crimp Cat® Hose Assembly Products.
7. The one (1) hour time frame for completion of the Eligible Order is from the time the Eligible Order is Received by Hastings Deering until the time Hastings Deering makes the completed Eligible Order ready for collection. The time at which the Customer, or any person sent on behalf of the Customer, arrives to collect the completed Eligible Order is irrelevant for the calculation of the one (1) hour time period.
8. The Customer must have a PCC account to be eligible for the Promotion and the receipt of any credit.
9. Where applicable, the credit will be applied within 14 business days from the date of the Eligible Order.
10. This promotion is able to be redeemed once per Customer per day during the Promotion Period.

## Exclusions

11. The Promotion does **not** apply:
  - a. when the order does not meet the criteria of Eligible Order outlined above;
  - b. when the order includes **reusable** Cat® Hose Assembly Products;
  - c. when the Customer purchases Qualifying Products as part of any Service Work Order;
  - d. Where the Qualifying Products require fitment (Promotion applies to **parts supply only**);
  - e. when the order contains more than two (2) Qualifying Products;
  - f. to all pressure test hose products;
  - g. any labour components.
