

Compact Machinery Online Promotion: Terms and Conditions

Valid from 1 May 2026 – 30 June 2026 inclusive

1. Subject to these terms and conditions, Hastings Deering (Australia) Limited (**Hastings Deering**) is offering an end of financial year (**EOFY**) sales price on Eligible Machinery (as defined in clause 2) between 1 May 2026 – 30 June 2026 (inclusive) (**Promotion**).
2. If you purchase any of the following Cat® models:
 - a. 301.7 Compact Excavator; or
 - b. 226B3 Skid Steer Loaderfrom available stock, collectively, the **Eligible Machinery**.
3. Promotional pricing is advertised as “from” pricing and is based on qualifying specifications of the Eligible Machinery. Actual pricing may vary depending on configuration, optional extras, availability and customer requirements.
4. The Promotion is only available to business customers that hold a valid ABN and, in the case of individual sole traders, are Australian residents aged 18 years or over.
5. You may offer to purchase Eligible Machinery under this Promotion by:
 - a. requesting a quote from a designated Hastings Deering branch; or
 - b. providing Hastings Deering with a valid order acceptable to Hastings Deering for the applicable Eligible Machinery, and Hastings Deering will then issue a purchase order (which will be subject to additional separate terms and conditions).
6. The promotional pricing is available for orders placed between 1 May 2026 and 30 June 2026 inclusive. Eligible Machinery must be invoiced and delivered within timeframes specified by Hastings Deering. These dates are subject to change without notice.

 - b. prices exclude any cost of transport, delivery or packaging, and Hastings Deering may charge these additional costs (where relevant);
