*collectively referred to as the “**Eligible Machinery**”,*

*from available stock at Hastings Deering (Australia) Limited (ABN 49 054 094 647) (**Hastings Deering**) during this campaign (1 May 2026 – 30 June 2026 inclusive) you may be eligible for the EOFY price point offer described in these terms and conditions (the **Promotion**).*

TERMS AND CONDITIONS OF THE PROMOTION

1. The Promotion only applies to the Eligible Machinery expressly listed above.
2. The Promotion only applies to Eligible Machinery that are currently in stock at Hastings Deering during the Promotion period of **1 May 2026 to 30 June 2026** (inclusive).
