

## **Terms & Conditions**

### **CI 2024 MACHINE CLEARANCE**

#### **New 2024 Cat® Machinery**

*You can purchase any 2024 plated Cat®:*

- (a) Excavators (313GC, 320GC, 330GC, 335-07);*
- (b) Asphalt Machines (CB7, AP-600, AP-1000); or*
- (c) Vibratory Soil Compactors (CS12GC, CS13GCLRC, CS68B),*

*collectively referred to as the “**Eligible Machinery**”,*

*from available stock at sale pricing from Hastings Deering (Australia) Limited (ABN 49 054 094 647) (**Hastings Deering**) during this campaign (15 February - 31 March 2025 inclusive), with the option to use financing from Caterpillar Financial Australia Limited (ABN 70 006 711 585) (**CFAL**) with a 20% deposit (the **Promotion**).*

#### **TERMS AND CONDITIONS OF THE PROMOTION**

1. The machine clearance Promotion only applies to the Eligible Machinery as expressly listed above.
2. The sale pricing available on the Eligible Machinery as part of the Promotion is provided in the price guide at Annexure 1 to these terms and conditions.
3. The Promotion only applies to the Eligible Machinery that are currently in stock at Hastings Deering for the period of **15 February to 31 March 2025** inclusive.
4. Finance is available from CFAL upon request, and subject to CFAL's approval, criteria, terms and conditions.
5. The Promotion includes a 12-month factory warranty on all Eligible Machinery, and extended warranties can be provided upon request at an additional cost to the customer.
6. The Promotion is only available to business owners that hold an ABN and, in the case of individual sole traders, are Australian residents over the age of 18 years.
7. Sale pricing is available for orders placed by new or existing customers between **15 February and 31 March 2025** inclusive (machines must be invoiced and delivered before 31 March 2025). These dates are subject to change without notice.
8. All applications for the Promotion that have elect to use financing from CFAL are subject to:

- a. credit approval by CFAL in their sole discretion; and
  - b. the execution of formal documentation on terms and conditions acceptable to CFAL. Fees and charges apply.
- 9. There is no agency or broker relationship between Hastings Deering or CFAL. As outlined in clause 8 above, all applications for the Promotion are subject to approval by CFAL in their sole discretion.
- 10. The Promotion cannot be used in conjunction with any other promotion or offer.
- 11. The Promotion is provided by Hastings Deering for your information only and does not constitute a binding offer to purchase, nor does it evidence Hastings Deering's intention to create a legally binding agreement with you.
- 12. Unless stated otherwise in or in conjunction with the Promotion:
  - a. pricing

    - ii. does not include GST, any cost of transport, delivery or packaging; and
  - b. the Promotion is subject to change from time to time at Hastings Deering's discretion; and
