

2026 Q2 Hastings Deering Construction Industry – Undercarriage CPRO Online Promotion

Subject to these terms and conditions, Hastings Deering (Australia) Limited (**Hastings Deering**) is offering a discount off Eligible Products (as defined in clause 2) purchased through approved Hastings Deering sales channels between 1 April 2026 and 30 June 2026 (inclusive) ("**Promotion Period**") (the **Promotion**).
2. The Cat® products eligible for the Promotion are as follows:
 - a. Full Undercarriage Rebuild – 25% off full retail price (subject to approval, see clause 4)

To order via CPRO or FDO, a customer must contact and order through a Hastings Deering Construction Industries Area Sales Representative. Orders must be placed during the Promotion Period. Products supplied from existing ground stock inventory are excluded and will not qualify for the Promotion.
4. **Full Undercarriage Rebuilds:** All Full Undercarriage Rebuilds are subject to prior approval by a Hastings Deering Construction Industries Area Sales Representative. Hastings Deering reserves the right to determine eligibility for rebuild discounts at its discretion.
5. Purchase Process and Discount Application: Discounts will be applied at the time of quotation and/or invoicing by Hastings Deering. This Promotion may be accessed via Hastings Deering representatives or approved systems.
