This SOC was prepared by the manufacturer in accordance with The Product Security and Telecommunications Infrastructure (Security Requirements for Relevant Connectable Products) Regulations 2023 (“**PSTI Regulations**”).

The Product Security and Telecommunications Infrastructure Act 2022 (“**PSTI Act**”) is designed to safeguard UK consumers from insecure technology products. Our responsibility as a manufacturer is to ensure that only compliant relevant connectable products are available in the UK market.


This SOC is based on a 3rd party test report dated 29 May 2025.

The test results show that, with regards to the Kilburn III speaker, we comply with the security requirements for manufacturers under Schedule 1 of the PSTI Regulations by way of meeting the conditions for deemed compliance under Schedule 2 of the PSTI Regulations. The conditions under Schedule 2 of the PSTI Regulations are that the manufacturer complies with certain cyber security provisions of ETSI EN 303 645.

Based on our own internal risk assessment, we can confirm that these test results are also applicable to the products listed in Appendix 1.

We can therefore confirm that in our opinion, we have complied with the deemed compliance conditions in Schedule 2 of the PSTI Regulations with regards to all the relevant connectable products listed in Appendix 1.
