ACTEON North America warrants ACTEON branded products against defects in material or workmanship as follows:

Manufacturer's Limited, 2 Year Warranty Coverage

- During the manufacturer's limited warranty, ACTEON will cover parts to repair a defective product sent into ACTEON for repair. After this period, the customer must pay all labor and parts charges.
- ACTEON, at its sole discretion, may choose to void the terms of this warranty if it determines that the product has sustained malicious or deliberate damage.
- Costs associated with shipping to ACTEON are the responsibility of the customer or dealer. Return shipping
 cost of non-warranty repairs is the customer's responsibility. ACTEON will pay for return shipping charges
 of items repaired under warranty.

Manufacturer's Limited, Remote Support Warranty Coverage

- Remote Support for Intra-oral imaging devices is covered by the manufacturer's warranty for up to 4 years. During this period:
 - ACTEON will perform remote troubleshooting.
 - ACTEON will assist with software and driver installations.
 - ACTEON will conduct software upgrades.
- Remote Support for Extra-Oral imaging devices is covered under the manufacturer's warranty for up to 5 years or the expiration of the manufacturer's warranty.

Comprehensive Warranty Coverage

- Sopix Sensors are covered by a comprehensive warranty for 24 months following the date of purchase from the dealer. During this time, up to two (2) repairs or replacements maximum are performed at no charge.
- ACTEON, at its sole discretion, may choose to void the terms of this warranty if it determines that the product has sustained malicious or deliberate damage.
- ACTEON will require a copy of an invoice as proof of date of purchase.
- ACTEON will pay all shipping costs during the comprehensive warranty period.
- The comprehensive warranty applies from the purchase date of the original item.

Warranty on Repair

- Repairs are covered by a 90-day limited manufacturer's warranty. This warranty covers only the work performed. Additional parts and functionality of the device are not covered.
- If more than 90 days remain on the original manufacturer's limited warranty, the repair will be covered for the remainder of the warranty rather than the 90 days.

Extra Oral Device Capture Computer Warranty Coverage

- Exclusions: The warranty does not cover damages resulting from malicious or deliberate actions by the customer. ACTEON reserves the right to void the warranty if evidence of intentional damage is found.
- Shipping Costs: Shipping costs associated with sending the Capture Computer to ACTEON for repair or replacement are the responsibility of the customer or dealer. ACTEON will cover the return shipping charges for items repaired or replaced under warranty.
- Capture Computer Components: The warranty specifically covers the computing components, including but not limited to the processor, memory, storage, and motherboard, within the Capture Computer.
- Extended Service Options: After the 24-month warranty period, customers have the option to purchase extended service plans and hardware upgrades for the Capture Computer.
- Support Services: Remote support for troubleshooting, software installations, and driver updates related to the Capture Computer is included during the warranty period Extra-Oral Device manufacturer's warranty period.

Please note that this warranty is separate from the comprehensive warranty covering other ACTEON products, and the terms and conditions may be subject to change.
