

Schedule 3E: Customers Leasing EV Charging Points from Finance

These terms and conditions apply to all Customers buying Services from Supplier while leasing the EV Charging Points from a Finance Provider under a Lease Agreement.

licence from Finance Provider to Customer only with no rights of ownership being granted.

1. Definitions & Interpretation

1.1 In the Contract the following words shall have the following meanings unless the context requires otherwise:

Finance Provider means the finance provider with whom the customer holds a Lease Agreement.

Lease Agreement means the agreement between the Customer and the Finance Provider detailing all arrangements, terms and conditions pertaining to the supply of the EV Charging Points.

2. Rights & Obligations of the Parties

2.1 Supplier's does not owe obligations to sell, deliver and transfer title to EV Charging Points to the Customer under this Agreement and the obligation to pay for the supply and install of EV Charging Points is not owed to the Supplier by the Customer. Arrangements for payment and ownership of the EV Charging Points is subject to a separate sale contract between Supplier and Finance Provider and Customer does not acquire any third-party rights of any kind under that contract.

2.2 Any terms and conditions pertaining to rights and obligations of title and payment shall not apply between Supplier and Customer and any documentation or rights to be supplied to the Customer including intellectual property licences shall be transferred to the Finance Provider with copies provided to Customer under a sub-

3. Project Completion Certificate

3.1 The Project Completion Certificate will be populated by Supplier and presented to the Customer at the time of, or as soon as reasonably practicable after, completion of the Installation Works.

3.2 As a condition precedent to the Customer's right to receive and Supplier's obligation to deliver any Services from the Supplier, the Customer shall sign the Project Completion Certificate in the form specified in the Annex to this Schedule within 5 business days of Supplier's request. Any delay in returning the signed Project Completion Certificate shall entitle Supplier to suspend performance of any of its obligation, including without limitation functionality of the EV Charging Points.

3.3 The parties acknowledge that there may be occasions where Supplier has completed installation of the Equipment but where ancillary works are delayed for reasons outside Supplier's control, including without limitation bay marking delayed due to severe weather. In these circumstances Supplier may present a Project Completion Certificate for partial completion and the Customer will sign and return the same. Supplier will issue a further and final Project Completion Certificate when all delayed works have been completed which the Customer shall sign and return. Supplier will indicate on any Project Completion Certificate whether it is for full or partial completion.
