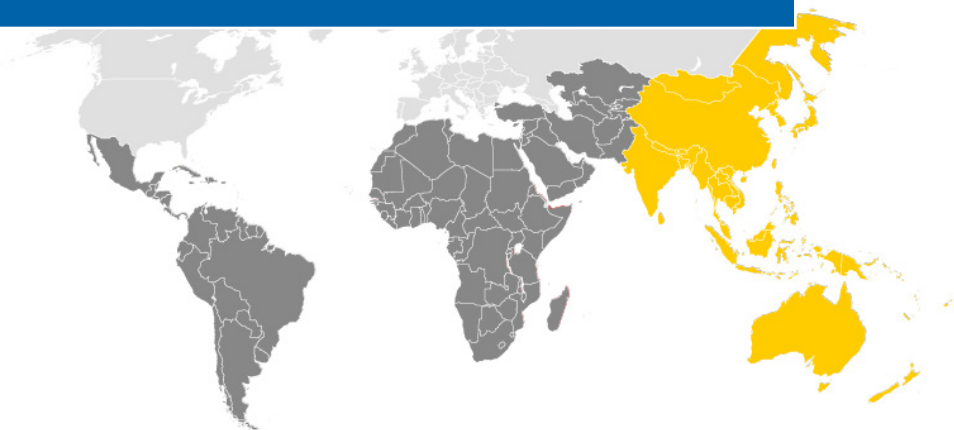

As the 2016 elections drew near and the prospects of a Rodrigo Duterte presidency became stronger, there were concerns that the economy might be adversely affected by the expected political volatility under the new regime. Since the start of the campaign season, Duterte had been rocking the establishment through controversial pronouncements and outbursts, attracting the enmity of leaders of the Catholic Church, the United States, and the United Nations. Based on a review of recent political and economic performance, this article argues that unless there are significant changes in the major sources of macroeconomic growth and stability, the Philippine economy would likely withstand the impact of a "Duterte shock." From 2010 to 2016, then-President Benigno Aquino balanced China's expansive maritime claim in the South China Sea. President Aquino challenged China by shifting the AFP's focus from domestic security to territorial defence, bolstering closer Philippine-US security relations, acquiring American military equipment, seeking from Washington an explicit security guarantee under the 1951 Mutual Defence Treaty (MDT), and promoting a strategic partnership with Japan. However, the Duterte administration is unravelling its predecessor's balancing agenda by distancing itself from the United States and gravitating closer to China, despite the Permanent Court of Arbitration (PCA) July 12 2016 award to the Philippines. President Duterte's foreign policy is directed at reviving the equi-balancing policy on China, in contrast to then-President Aquino's balancing strategy. This is best exemplified by his efforts to harness China for several major infrastructure and investments projects in the Philippines and to resort to bilateral negotiations with Beijing. The present article argues that instead of relying on the US, President Duterte is fostering closer security partnership with Japan to equi-balance an emergent China. (JCSA/GIGA)

Citizens who support populist leaders are often portrayed in negative terms. They are disparaged for their prejudice and naiveté, some even earning the label "basket of deplorables" from Hillary Clinton. Rodrigo Duterte's supporters were not exempted from such criticism. In the 2016 Philippine presidential race, they were pejoratively labelled Dutertards, which pathologised their fervent and unrelenting support for the controversial candidate. This article interrogates such depictions by examining the logics that underpin Duterte's strong public support. I argue that part of Duterte's appeal hinges on "penal populism," built on two political logics that reinforce each other: the politics of anxiety and the politics of hope. While the former foregrounds the language of crisis, danger and uncertainty, the latter reclaims democratic agency. The article examines the articulations of these logics among Duterte's supporters based on ethnographic fieldwork in disaster-affected communities where Duterte enjoyed decisive victories. Despite the limits of elections as a mechanism to secure accountability and ensure substantive representation, the 2016 elections drew the highest turnout across elections held since the political transition in 1986, a clear indication of electoralism. The high turnout may be a result of a relatively tightly contested race, with each of the main contenders appealing to constituencies that they symbolically represent. Nonetheless, the 2016 Presidential elections remained personality-oriented, media driven and political clan dominated. The eventual winner, Rodrigo Roa Duterte, garnered the presidency given a combination of factors: the clarity of his campaign message – focused on curbing a single problem (criminality, in general, and the illegal drug trade, in particular) that he elevated as the most serious concern that the next president should address; significant support from a geographic area (Mindanao) and associated ethno-linguistic groups (i.e., Bisaya); and, serious questions of character and competence raised against his opponents (i.e. Binay, Poe and Roxas). This article argues that, in Duterte's "war on drugs", state power is exercised through the body in a spectacle of humiliation and violence. The analysis draws from the work of Foucault (1979) on the political value of a spectacle of the body to explain the distinctive character of Duterte's violent war on drugs; of Feldman (1991) on the use of the body as an object in which violence is embodied to send political messages; of Agamben (1995) on eliminating life supposedly devoid of value; and on Mumford et al. (2007), who pointed to the popularity of "violent ideological leaders." I argue that, under the Duterte administration, criminals are humiliated and killed in a spectacle of violence that politicises their lives, sending a message that intimidates others. In the process, law-abiding citizens are meant to feel safe, which is seen as likely to increase the newly elected president's popularity and his power as chief executive. Duterte has thereby politicised life, not only putting criminals outside the benefit of state protection but actively targeting them. Duterte is the first mayor and president to have actively targeted criminals and, in doing so has encouraged other politicians to follow his example. The politicisation of the bodies of criminals is distinctive in Duterte's form of violence. This article is drawn from data sets of individual killings when Duterte was either serving as or acting behind the mayor of Davao, and compared with cases of drug-related killings since he became president on 30 June 2016. Early in his administration, Rodrigo Duterte, the controversial sixteenth president of the Philippines, did what no other Filipino president has done before – announce a separation from the geopolitical interests of its former colonial master, the United States of America. Beyond the personal slights caused by the US criticism of his anti-drug campaign lies a deeper sense of historical grievance that has been ingrained in Duterte's generation and his identity as a Mindanaoan. Not only does he represent Mindanao's resentment towards "imperial Manila," but also a historical blowback against "US imperialism." Duterte's nationalist exhortations can be traced to the cycle of regime narratives in the Philippines, which serves as a medium for institutional continuity and change through the mobilisation of ideas at a discursive level. By reviving the anti-US nationalism of his youth, Duterte is repudiating the liberal reformist, albeit elitist, narrative of the Aquino-to-Aquino regimes. Duterte's so-called "pivot to China" is also a dramatic reversal of his predecessors' strong anti-China and rabidly pro-American foreign policy position. This paper blends Vivien A. Schmidt's discursive institutional analytical framework with Stephen Skowronek's concept of presidential leadership in political time to analyse how crafted narratives are transformed into governance scripts that bind together a coalition of interests within a particular institutional setting. Since assuming the presidency, Rodrigo R. Duterte has "stuck to his guns" in carrying out his campaign pledge to launch a violent anti-drug campaign. Duterte's presidency was preceded by six years of political stability and high growth under the relatively liberal and supposedly reformist administration of President Benigno "Noynoy" S. Aquino, III. What did voters find so appealing about Duterte given that drugs and criminality were not a major national concern until he launched his candidacy? Unlike previous populist politicians in the post-Marcos Philippines, Duterte's strongest support did not come from the poorest voters but rather from the elite and the middle class who most feared for their personal security. Although Aquino was widely perceived to be personally honest, his administration had become "systemically disjunctive" and vulnerable to replacement by violent illiberalism because its narrative of "good governance" had been undermined, its strategic allies were weakened, and liberal institutions discredited. Duterte is an illiberal populist who changed the prevailing political order into an illiberal one through a new law-and-order governing script, new key strategic groups (the communist left and the police), and the quick removal of remaining liberal constraints (particularly in Congress and the Supreme Court). Duterte constructed a strongman political model at the local level before "nationalising" it after his election as president. (JCSA/GIGA)
