



TERMS AND CONDITIONS WIN A YEAR OF DRIVING AN OPEL CORSA YES

1. General

1.1

These terms and conditions apply to the promotional campaign "WIN A YEAR OF DRIVING AN OPEL CORSA" (hereinafter: the "Promotion") organized by Opel Nederland.

1.2

This Promotion is offered by Stellantis Nederland N.V., also trading under the name Opel Nederland (hereinafter: "Opel Nederland"), with its registered office at Lemelerbergweg 12, 1101 AJ Amsterdam, in collaboration with MediaMarkt Nederland, located at Wilhelminakade 161, 3072 AP Rotterdam.

1.3

The Promotion is only valid during the 2026 World Cup period: from 11 June 2026 up to and including 19 July 2026 (hereinafter: the "Promotion Period").

1.4

All persons participating in the Promotion are bound by these terms and conditions. By participating, the entrant declares to accept the content of these terms and conditions. No correspondence can be entered into regarding the content of these terms and conditions.

1.5

All employees of Opel Nederland, its affiliated sales and service organizations, and anyone directly or indirectly involved in the organization of this Promotion, as well as their family members, are excluded from participation.

1.6

Opel Nederland reserves the right to terminate the Promotion at any time or amend these terms and conditions without providing reasons. Any revised version will be published on www.opel.nl, including the date of amendment. Participants are expected to regularly check this website.

1.7

After the Promotion Period, one winner will be selected and informed. This winner will receive the prize as described under the section "Prize" in these terms and conditions.

1.8

Where applicable, Opel Nederland will at all times comply with the Dutch Code of Conduct for Promotional Games of Chance 2014.



2. Prize

2.1

One (1) winner will be selected from all participants.

The winner will receive the right to drive an Opel Corsa YES for one (1) year (hereinafter: the "Prize").

The Prize starts with the collection of the Opel Corsa YES on a day of choice, no later than 3:00 PM, at the Opel dealership selected by the winner. The exact handover time will be agreed upon with Opel Nederland.

The Opel Corsa YES must be returned one year later, on an agreed date and time, to the selected Opel dealership. The exact return date and time will be agreed upon with Opel Nederland.

2.2

The winner will be selected no later than Monday, 17 August. The winner will be notified by email.

2.3

The Prize is personal, non-transferable, and cannot be exchanged for cash or other goods or services.

2.4

The Opel Corsa YES will be made available for one year.

Exact handover and return times will be agreed upon with Opel Nederland.

Depending on the model, the vehicle will be delivered fully charged or with a full tank. The vehicle must be collected and returned at the Opel dealership selected by the winner. The winner will receive a €500 allowance for charging or refuelling the vehicle during the year.

An insurance excess of a maximum of €500 applies in case of damage. This also applies if the vehicle requires professional cleaning after use.

Any fines are at the expense of the winner.

Additional usage conditions are included in the loan agreement, which must be signed on the day the vehicle is collected.

2.5

Opel Nederland will pay any applicable gaming tax.



3. Participation

3.1

Participation and eligibility for the Prize is only possible if the entrant participates in the "Search & Win" campaign: "Spot the Opel Corsa YES and you could drive it for free for one year" via opel.nl/yes during the Promotion Period.

3.2

Participation is voluntary and does not depend on the purchase of any product or service. Participation is only possible if the participant:

- Has participated in the Search & Win campaign via opel.nl/yes
- Has a permanent residence in the Netherlands
- Is at least 16 years old
- Holds a valid category B driver's license
- Has provided correct personal details

3.3

If the Promotion is co-organized with a third party, the terms and conditions of that party may also apply. In case of conflict, the Opel Nederland terms and conditions shall prevail.

4. Winner Selection

4.1

One winner will be selected by an independent jury from all participants.

4.2

If the winner does not respond within five (5) working days after notification, the right to the Prize will lapse and a new winner will be selected.

4.3

To claim the Prize, the following documentation is required:

- First and last name, address, and phone number
- Valid Dutch driver's license (AM or B) and identification/passport



5. Entry Requirements and Winner Determination

5.1

To be eligible for the Prize, the entrant must:

- Participate in the Search & Win campaign on opel.nl/yes during the Promotion Period
- Accept the Privacy Policy, Marketing Communication terms, Cookie Policy, and these terms and conditions
- Agree to the terms of the loan agreement to be signed upon handover of the vehicle

Failure to meet these conditions will result in disqualification.

6. Exclusions

6.1

Participants providing incorrect information will be excluded.

6.2

Opel Nederland reserves the right to exclude participants from the Promotion at any time if it believes that a participant has violated one or more participation conditions, has provided incorrect or incomplete information, or has otherwise acted in a manner that is legally impermissible. Any exclusion from the Promotion will be communicated in writing.

6.3

Opel Nederland shall not be liable for any loss, delay, or injury resulting from the Prize, in any form whatsoever. With regard to the awarded and/or to-be-awarded prizes, only the standard warranty provided by the manufacturer and/or supplier shall apply, where such warranty exists and is applicable.

6.4

Opel Nederland takes the utmost care in organizing its promotions and managing its websites. Nevertheless, it is possible that the information displayed or provided may be incomplete or incorrect. Any inaccuracies, typographical errors, or other mistakes in materials published by Opel Nederland (including promotional materials) cannot give rise to any claims against Opel Nederland nor create any obligation on the part of Opel Nederland. Opel Nederland accepts no liability for the loss of submitted entry forms and/or attachments, nor for the submission of incorrect or incomplete (personal) data by a participant.



6.5

Opel Nederland shall not be liable for any (consequential) damages caused by technical or editorial errors or omissions occurring on the website, nor for any (consequential) damages resulting from the use, presentation, availability, or temporary unavailability of the website or any links to third-party websites.

6.6

Opel Nederland shall not be liable and/or responsible for any costs incurred by the participant in connection with participation in the Promotion or the use of the Prize.

7. Processing of Personal Data

7.1

Participants' data will be recorded in a database maintained by Opel Nederland. Opel Nederland processes the personal data provided by participants in connection with their participation in the Promotion. The purpose of this data processing is to enable the proper administration and execution of the Promotion.

If the participant has given their consent, their data may also be used to inform them about products, services, and promotional offers from Opel Nederland, its dealers, and affiliated companies.

7.2

In accordance with the General Data Protection Regulation (GDPR), participants have the right to access and obtain information about their personal data, the right to rectification, the right to erasure, the right to restriction of processing, the right to obtain a copy of their personal data for their own purposes or to transfer these to a service provider of their choice ("right to data portability"), and the right to object to the processing of their personal data when such data is processed for direct marketing purposes or on the basis of a legitimate interest. Participants also have the right to withdraw their consent at any time, where processing is based on their consent. All of these rights apply to the extent permitted under the GDPR. Participants can exercise these rights by submitting a request to: privacyrights@opel.com.

7.3

All personal data obtained from participants in the context of the Promotion will be treated as strictly confidential and processed in accordance with applicable data protection laws.

7.4

All personal data collected in the context of this Promotion is subject to Opel Nederland's privacy policy as published on www.opel.nl, insofar as such policy does not deviate from the provisions set out in these terms and conditions.



8. Applicable Law and Disputes

8.1

Questions and complaints regarding the implementation of this Promotion can be submitted to Opel Nederland. Opel Nederland will contact the participant to respond to the question and/or to further handle the complaint. Opel Nederland will make every effort to resolve the complaint to the participant's satisfaction. If the complaint is not resolved satisfactorily and the Promotion qualifies as a game of chance, the participant may submit a complaint to the Dutch Gaming Authority (Kansspelautoriteit).

8.2

These terms and conditions and the Promotion are governed by Dutch law.

8.3

Any disputes arising from or in connection with these terms and conditions or the Promotion shall be exclusively submitted to the competent court in Amsterdam, the Netherlands.
