

Promotion Terms and Conditions (participant)

- By participating in the Fritel BBQ promotion, the participant agrees to these terms and conditions.
- The Fritel BBQ, with a retail value of **€99**, can be purchased for **€0.01** with a purchase of **€500 or more** in participating products during the period from **18 May up to and including 31 May 2026**, while stocks last (**limited stock available**).
- From **17 May 2026 at 18:00**, it is already possible to take advantage of the promotion via the **Early App (MediaMarkt App)**.
- The promotion applies to purchases made **in-store**, on **mediamarkt.nl**, and via the **MediaMarkt App**, excluding **Marketplace sales**.
- Purchases of services related to participating products (such as calibration, screen protectors, delivery charges, etc.) are **not included** in the valuation of participating products.
- If a participating phone is purchased **in-store** in combination with a phone subscription, the **retail price of the standalone device** will be included in the valuation of the participating products.
- Online phone subscriptions purchased in combination with a participating phone are **not eligible** for participation in the promotion.
- The retail value of **€99** of the Fritel BBQ will be reflected on the invoice/order at a price of **€0.01**.
- The participant is entitled to a maximum of **one Fritel BBQ per order/invoice**.
- This promotion is valid **while stocks last**.
- The Fritel BBQ cannot be exchanged for cash. In the event of a return shipment of the Fritel BBQ only, **no refund or credit of any kind** will be given.
- MediaMarkt reserves the right to amend these promotion terms and conditions at any time. Any changes to the BBQ promotion will be announced via **mediamarkt.nl**.
- The Fritel BBQ promotion is a **B2C promotion** and cannot be combined with other offers/promotions.
- Unfortunately, **MyMediaMarkt vouchers** cannot be redeemed in combination with the Fritel BBQ.

Delivery

- For purchases that are taken away immediately, the participant will receive the Fritel BBQ directly at the time of purchase.
- In the case of home delivery, the Fritel BBQ will be delivered together with the main product(s) as an additional parcel.

Returns

- In the event of a full return of all participating products, including the Fritel BBQ, the participant will receive a refund of the purchase amount.
- If a participant returns part of the participating products, he or she will retain the right to the Fritel BBQ, provided that the total value of the products kept remains at least **€500**.
- If a participant returns part of the participating products and, as a result, the total value of the products kept falls below **€500**, the right to the Fritel BBQ will lapse and the value of the Fritel BBQ (**€99**) will be deducted from/offset against the returned products.
- The return of the Fritel BBQ must comply with MediaMarkt's return procedure conditions (including, but not limited to: **new in box, fit for resale, and unused**).
- It is not possible to return the Fritel BBQ for cash.

Warranty

- The warranty period for the Fritel BBQ is **2 years**.
- If the same model is no longer available for replacement within 2 years, MediaMarkt reserves the right to provide a comparable product.

Stock

- This promotion is valid **while stocks last**.
- There will be **no backorders** or later deliveries of the Fritel BBQ.
