R&H continues to set the pace in Colorado's legal market. Thanks to Alec's efforts, we've already onboarded 23 talented attorneys and paralegals in 2025—but client demand is growing even faster. 


Please join us in congratulating Nicole Griffard, who is now leading our Estate Planning Practice as Partner. We're excited to see how the practice continues to grow under her leadership.


