1 Introduction

- 1.1. This document presents the specific Definitions applicable to the **KPN Telecom Collocation Service for Interconnect Access** provided by KPN to **Service Taker**, as used in the **Framework Agreement**, **Individual Agreements**, and supporting manuals and schedules.
- 1.2. Definitions that apply for all of the **KPN Telecom Collocation Services** are presented in **General Definitions**.
- 1.3. This document is an 'add-on' to the **General Definitions** and all other general documents.

2 Service Definitions Collocation for Interconnect Access

Collocation Cabinet Footprint	Physical ground-space occupied by the Service Taker Equipment cabinet(s). For KPN Telecom Collocation for Interconnect Access Services the footprint will constitute a minimum of 1 standard Service Taker Equipment cabinet (see Technical Manual for details)	SD
Collocation Space (Opstelruimte)	If an Individual Agreement concerns the sharing of one of the KPN Interconnection Collocation Facilities: Interconnection Collocation Space	All
Opstelruimte	Indien een Individuele Overeenkomst betrekking heeft op medegebruik van een KPN Collocatieruimte ten behoeve van Interconnection als bedoeld in de eerste overweging van de Raamovereenkomst: Interconnectie opstelruimte.	LB
Interconnection Collocation Room	A room within an Interconnection Collocation Facility where Collocation Space is made available to Service Taker for the provisioning of KPN Telecom Collocation Service for Interconnection.	SD
Interconnection Collocation Space	Potential or existing space within a Collocation Room on which a Collocation Facility can or has been built for the provision of KPN Telecom Collocation for Interconnect Access services.	SD
Interconnection Collocation Facility	A building or construction belonging to KPN, in which Collocation Space is made available to Service Taker for the provision of KPN Telecom Collocation Service for Interconnect Access .	SD
Physical Collocation Cabinet Set	A set of one standard cabinet, which form part of the Standard Facilities within a Physical Collocation Facility, owned by KPN and used by Service Taker for the provision of Collocation for Interconnect Access .	SD

Definitions Interconnection

Service Taker Equipment (Bedrijfsapparatuur)	The multiplexing and/ or transmission equipment (without any routing and/ or switching functionalities) of Service Taker, including the ancillary facilities, necessary to make interconnection with and/ or special access to KPN's fixed public telephone network.	SD
Bedrijfsapparatuur	De multiplexing- en/ of transmissieapparatuur (zonder enige routerings- en/ of schakelfunctionaliteiten) van Dienstafnemer, met inbegrip van de bijbehorende ondersteunende voorzieningen, die benodigd is om interconnectie met en/ of bijzondere toegang tot het vaste openbare telefoonnetwerk van KPN.
