Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 41.26 tCO₂e by 2029. This is a reduction of 3,37%

This reduction is mainly driven by the scope 3 Cat 7 & 8. Unfortunately, we have not the reduction emission plan from our carriers.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 00 tCO₂e, a 00%ge reduction against the 2023 baseline and the measures will be in effect when performing the contract.

NA at the carbon emission level of TERUMO Neuro UK as it is our first real CRP performed with an environmental consultancy company.

At the European level, TERUMO Neuro has started thinking about grouping some of these devices into a single box and optimizing these shipments and reduce their number.

Terumo Group's (our Parent company) greenhouse gas **(GHG) emissions reduction targets** have been **approved by the Science Based Targets initiative (SBTi)** as being aligned with the common goal to limit global temperature rise to 1.5°C above preindustrial levels¹.

In the future we hope to implement further measures such as:

TERUMO Neuro UK will move these offices in April 2024. These will have an energy balance of level C while the current office level is D. the location of a bus stop and a metro station close to the office will allow the employee who wishes to use the public transport. Finally, the new car park allows the installation of charging stations in the near future.
