



# Notes of guidance for school transport for pupils of primary age

Please read these notes carefully before completing the application form.

# Children starting primary school education from September 2015

From September 2015, new entrants into Reception Year will be provided with free home to school transport if they attend the nearest available primary school to their home address and reside, as measured by the shortest walking route:

- 2 miles or more from that school, until the end of year 3.
- 3 miles\* or more in years 4, 5 and 6.
- \* The exception to this is where a child qualifies by virtue of parental low income.

In the event that a faith or out of county school is nearer, an entitlement to transport will exist to that school as well as the nearest other maintained school or academy within the Essex County Council area, providing the distance criteria is met.

# Low income families

Where a family is eligible for free school meals or has an annual household income less than £16,190\*\*, the distance requirement remains at 2 miles or more when the child reaches year 4.

Evidence of a qualifying benefit will be required every academic year in order for transport to continue.

# Voluntary aided faith primary schools

Where a family is eligible for free school meals or has an annual household income less than £16,190, home to school transport will be provided to children that:

- Attends the designated Faith school for their home address.
- Are baptised into that Faith.
- Reside over 2 miles away by the shortest available walking route.

For Roman Catholic (RC) schools, the 'designated faith school' for this purpose is the school which the RC Diocese and the County Council have agreed as the RC school for the area of the home address. In the case of other faiths, transport will only be provided to the nearest school of that faith, if the relevant income and distance criteria are met.

# Children of primary school age in the 2014/15 academic year

Essex County Council will provide free home to school transport for children that attend their designated (catchment) or nearer school and meet the 'qualifying distance' criteria which are:

- 2 miles or more from that school, until the end of year 3.
- 3 miles\* or more in years 4, 5 and 6.
- \* The exception to this is where a child qualifies by virtue of parental low income.

# What type of transport is provided?

The County Council has many contracts transporting children to schools. If your child is entitled to home to school transport, they will be provided with a seat on one of these contract vehicles. (Passenger assistants are provided on vehicles with 25 or more entitled children).

### **Fuel reimbursement**

Essex County Council is able to offer parents/carers a payment in advance in order for them to take their children to school when the cost of the payment is less than the cost of Essex County Council providing transport.

The mileage rate is paid at 45p to cover fuel costs for return journeys at the start and end of the standard school day. Please tick the box on the application form if you would like to be considered for advanced fuel reimbursement. If 45p is in excess of the cost of Essex County Council providing transport, an alternative rate of 17p can be considered should this be cost effective for Essex County Council.

# When can a student travel?

Parents/carers are responsible for ensuring that an application has been made to Essex County Council for their child to be provided with transport.

# How should students get to and from the pick up point drop off point?

- Parents/carers are responsible for the safety and behaviour of their children and therefore must ensure that students know how to get to and from the bus safely and in time for the arrival of the vehicle. This may include accompanying them.
- Students should wait for the vehicle sensibly without inconveniencing local residents or businesses.
- Students should aim to be at the stop 5 minutes before the scheduled departure time.

# **Behaviour**

Essex County Council is committed to maintaining acceptable standards of behaviour on all school transport and appropriate action will be taken against children who misbehave on vehicles. In extreme cases this may involve the withdrawal of transport provision.

# **Change of address**

If you move address, or your child leaves school, you must inform us in writing immediately. If you move and wish your child to remain at their existing school, your application will be re-assessed from your new address. If you require transport from your new address to a different school you will need to complete a new application form. Changes of address cannot be taken over the telephone, for security reasons we must receive notification in writing. This is for your child's protection.
