# What are Cookies?

Cookies are small text files stored on your computer or smartphone when you visit web pages. They are widely used in order to make websites work, or work more efficiently, as well as to provide us information for different purposes.

#### 3. Cookie Categories

# a. First/Third-Party Cookies Clause

- **First party cookies:** cookies that HDR Global Trading Limited drop to keep track of what you have in your basket and to remember you when you return to our site.
- **Third-party cookies:** cookies dropped by third parties HDR Global Trading Limited has a contractual relationship with. We use third party cookies to enable specific functionalities and enhance the customer experience.

## b. Session/Persistent Cookies

Cookies can remain on your computer or mobile device for different periods of time:

- i. "Session cookies" exist only while your browser is open. These are deleted automatically once you close your browser.
- ii. **"Persistent cookies"** survive after your browser is closed. They can be used by the website to recognize your computer when you open your browser and browse the Internet again.

#### c. Purposes

 Advertising/Targeting: Marketing cookies are used to offer content that is more relevant to the user and adapted to your interests based on your browsing habits.
 They are also used to measure and control the effectiveness of campaigns. For example, they register whether a website has been visited or not, the links you have followed, as well as which content has been used. This information is used to create an interest profile so that only content that is interesting for you is displayed. If you withdraw your consent to marketing cookies, this does not mean that you will see or receive less content as a result. Rather, it means that the content you see and receive is not tailored to your individual needs.
