Management discussion of fund performance

The management discussion of fund performance presents the views of the portfolio management team concerning significant factors and developments that have affected the Fund's performance and outlook.

Results of operations**Investment performance**

For the six-month period ended June 30, 2022, EdgePoint Global Portfolio, Series A, decreased 16.0% versus a decrease of 18.8% (C\$) for its benchmark, the MSCI World Index. The MSCI World Index is a market-capitalization-weighted index comprising equity securities available in developed markets globally.

We manage the Fund independently of the index we use for long-term performance comparisons. Differences including security holdings and geographic/sector allocations may impact comparability and could result in periods when our performance differs materially from the index. During the period, the Fund's outperformance versus the index can mainly be attributed to security selection within the Consumer Discretionary sector. In addition, the Fund's positive allocation effect and security selection within the Information Technology sector further contributed to outperformance.

Please refer to the *Past performance* section for the performance of other series, which differ from Series A due largely to varying expenses and/or taxes incurred by each series, as explained in the Prospectus.

No sector or security meaningfully contributed to overall performance.

Meaningful detractors to investment results included:

- Berry Global Group Inc.
- Affiliated Managers Group, Inc.
- SAP SE
- The Middleby Corp.
- Koninklijke Philips NV

These companies detracted approximately 5.9% to overall performance in the last six months.

While we provide these results to fulfill the disclosure requirements of this report, we measure investment success over periods of 10 years or more and believe it takes considerable skill to consistently add value over the long term. We don't believe any meaningful conclusions can be drawn based on such a short period.

Portfolio transactions

During the period, the Fund net purchased \$51.2 million worth of investments. This resulted in a decrease in the Fund's cash position. Portfolio turnover was 20.8% for the six months ended June 30, 2022 compared to 49.0% for the year ended December 31, 2021.

Businesses purchased

Examples of companies added to the Fund include:

- Cellnex Telecom SA – A Spanish wireless infrastructure operator that manages cellular towers across Europe.
- Schneider Electric SE – A French multinational manufacturer of energy management and automation products.
- Sea Ltd., ADR – A Singaporean developer of internet services including payment, e-commerce and gaming.

Businesses sold

We generally sell a stake in a business for one of two reasons. First, if our thesis about the business is deemed no longer valid. Second, there is a constant culling process whereby we continuously strive to upgrade the quality of the Fund with better ideas.

During the period, examples of businesses sold include:

- Sony Group Corp.
- O'Reilly Automotive, Inc.
- Diageo plc

Portfolio composition**Sector exposure**

Overall sector exposure shifted primarily as a result of investment decisions and changes in stock prices. The most significant change was an increase of approximately 2.0% in the Fund's Communication Services sector investments mainly due to the purchase of Cellnex Telecom S.A. and Sea Ltd., ADR. The Fund's Financial sector investments decreased by about 2.7% mainly due to the decreased positions in Affiliated Managers Group, Inc. and Brookfield Asset Management Inc. The Fund's cash position of 3.4% as at June 30, 2022 is down slightly from 3.9% at December 31, 2021.

Portfolio transactions are a result of our "bottom-up" stock selection process. We don't construct the Fund with an index or benchmark in mind. As a result, the Fund's composition is typically very different from its benchmark index.

Income, fees and expenses

The management expense ratio ("MER") has not changed significantly for all series of units of the Fund. We continue to focus on maintaining low operating costs. Our goal as it relates to MERs has always been to be among the lowest-cost fund providers in our distribution channel. Please refer to the Financial highlights section for more information about MERs for all series of units.

The overall changes in income, operating expenses and income attributable to unitholders of redeemable units over the prior period is a result of a change in the Fund's size and the overall composition of businesses in the Fund.

Unitholder activity

During the period ended June 30, 2022, the Fund's net assets attributable to unitholders of redeemable units ("NAV") decreased to \$10.0 billion from \$12.0 billion as at December 31, 2021. Of this

decrease, \$104.5 million is a result of net outflows to the Fund and a \$1,865.1 million loss attributed to operations.

Recent developments

Rising interest rates, increased levels of inflation and soaring energy prices were some of the major concerns that investors were faced with in the first half of calendar year 2022. This increased level of uncertainty is typically followed by market volatility, which many investors have experienced across various asset classes. Major equity indices such as the MSCI World Index, S&P 500 Index and S&P/TSX Composite Index declined 19%, 18% and 10% (total returns, in C\$) respectively from December 31, 2021 to June 30, 2022.

We don't get too fussed by noisy headlines. The reality is nobody knows if the markets will continue to experience a pullback, how sharp it could be or how long it might last. We aren't good at "timing" the market and don't believe anyone can consistently do it well. Rather, we consider the facts surrounding the underlying businesses we own and make judgments based on those facts.

We believe that the biggest risk to investors' long-term returns is unfortunately likely themselves. During periods of volatility, investors tend to let fear dictate their decisions which results in the dreaded buy high sell low behavior.

It's our view that market volatility is a friend to the investor who knows the true value of a business and the enemy of the investor who does not. Despite the portfolio experiencing a negative year-to-date return, we stay true to our investment approach and focus on the long-term growth prospects of the businesses we own.

We've used the volatility to our advantage and were active throughout the six-month period. We purchased 3 new businesses in the Fund while selling 4 businesses. In addition, we increased our position in 11 existing businesses and decreased our position in an additional 11 businesses.

Although the world is very uncertain, we approach investing with measured confidence and an approach that has navigated investors through all types of market and economic environments.

Related parties**Manager**

The Fund is managed by EdgePoint Wealth Management Inc. ("EdgePoint"). As Manager, EdgePoint provides (or arranges for) investment management, distribution, marketing and promotion of the Fund. As compensation for providing these services, EdgePoint receives a monthly management fee based on the daily average NAV of each series of the Fund (see *Management fees*).

EdgePoint is also responsible for the Fund's day-to-day operation. EdgePoint will often incur, on behalf of the Fund, costs associated with the Fund's operations including, but not limited to, legal fees, custodian and safekeeping fees, audit fees, administrative and operating costs, including commissions, brokerage fees, trustee fees, taxes, registrar and transfer agency fees, unitholder servicing costs, the costs of preparing and distributing annual and semi-annual reports, prospectuses, statements and investor communications, regulatory filing fees, fees and expenses payable in connection with

the Independent Review Committee ("IRC"), interest and other general operating expenses that could include allocated salaries, overhead and other costs directly related to the Fund's operations. These services are in the normal course of operations and are charged at the rate agreed to by the parties. EdgePoint is entitled to be reimbursed by the Fund for these operating costs.

The management fees payable by Series I and Series I8 unitholders are negotiated and paid directly by them. Operating expenses for Series I and Series I8 unitholders are EdgePoint's responsibility and are not charged to the Fund.

Investment Advisor

EdgePoint Investment Group Inc. ("Investment Advisor") is the Fund's portfolio advisor. The Investment Advisor is entitled to be reimbursed by EdgePoint for certain operating expenses associated with its advisory services, which are paid by EdgePoint with the fees received as Manager. The Fund is not separately charged for the services of the Investment Advisor.

Independent Review Committee

EdgePoint has appointed an Independent Review Committee ("IRC") consisting of three independent members and established under the Canadian Securities Administrators' National Instrument 81-107. The IRC's mandate is to review and provide input on EdgePoint's written policies and procedures that pertain to conflict of interest matters with respect to EdgePoint-managed funds, including EdgePoint affiliates. Additional information about the IRC is available in the Simplified Prospectus and Annual Information Form for the Fund. IRC members receive fees and reimbursement of expenses for services provided to the Fund.

Other

EdgePoint provided start-up investment capital to the Fund and sufficient initial capital to each of its series to permit them to be valued on a daily basis. EdgePoint's investment in the Fund is recorded at the NAV per unit of each series, as applicable. From time to time, EdgePoint may provide the initial capital required on the introduction of a new series to the Fund.

Management fees

As compensation for the investment management, distribution, marketing and promotion services provided, EdgePoint, the Manager of the Fund, receives a monthly management fee based on the daily average NAV of Series A, Series A(N), Series AT6, Series A(N)T6, Series F, Series F(N), Series FT6, and Series F(N)T6. Management fees for Series I and Series IT8 are negotiated and paid directly by unitholders and not by the Fund.


Past performance





Series A(N)T6





Series AT6








