Management discussion of fund performance

The management discussion of fund performance presents the views of the portfolio management team concerning significant factors and developments that have affected the Fund's performance and outlook.

Investment objectives and strategies

The Fund seeks to provide a combination of long-term capital appreciation and income generation by investing primarily in Canadian equity and fixed-income securities. We (the portfolio management team) invest in companies that have strong competitive positions and defensible barriers to entry, strong long-term growth prospects, and are run by competent management teams. We endeavour to acquire ownership stakes in these businesses at prices below our assessment of the company's true worth.

We're long-term investors with an investment horizon greater than five years. We believe the best way to buy a business at an attractive price is to have an idea that isn't widely shared by others – which we refer to as a *proprietary insight*.

Our fixed-income approach begins with fundamental credit analysis supplemented with an analysis of macroeconomic factors affecting economic growth to uncover relative value opportunities both within and across different market sectors.

Our approach is deceptively simple. We buy good, undervalued businesses and hold them until the market fully recognizes their potential. Following this approach requires an ability to think independently and a commitment to embrace the thorough research required to uncover opportunities the market doesn't fully appreciate.

Risk

We believe risk is best managed by applying in-depth, thorough research to each investment idea in order to understand the risks of an individual business, which we weigh against its return potential. We take a common-sense approach to risk by assessing how much money can be lost and the probability of losing it. While this approach may seem overly simplistic, it provides vital clarity about the true investment risks.

There were no significant changes during the period that affected the overall level of risk associated with the Fund.

As discussed in the Prospectus, the Fund remains suitable for investors with an investment horizon of at least five years and who are willing to accept low to medium investment risk.

There are several types of risks that include, but are not limited to:

Concentration risk

Concentration risk can occur by holding a small number of investments, which may reduce the Fund's diversification and liquidity. We invest with conviction and, as a result, the Fund is concentrated in our best ideas. This concentration allows individual holdings to have a meaningful impact on returns. It also allows us greater in-depth knowledge about each company in the Fund, a key element in reducing an investment's potential risk.

As at December 31, 2024, EdgePoint Canadian Growth & Income Portfolio's equity holdings increased from 65 at the end of 2023 to 74 at the end of 2024. Although the number of equity holdings gives the appearance of an unconcentrated portfolio, approximately 46% of the portfolio's assets are in the top 25 names. 24 out of the 74 business ideas are foreign companies and 48% of the equity holdings are invested in businesses with a market capitalization of less than C\$10 billion. Part of our investment team's responsibilities includes continually monitoring our existing holdings to ensure that each remains the best use of capital.

The number of fixed-income holdings decreased from 144 at the end of 2023 to 125 at the end of 2024.

Currency risk

The Fund is valued in Canadian dollars; however, it may invest in foreign securities denominated in foreign currencies. To reduce the impact of short-term currency fluctuations, we typically hedge all of our fixed income foreign currency exposure. In addition, we may hedge all or a portion of our equity-based foreign currency exposure depending on our view of a currency's relative value and its associated risks.

Our investments in foreign securities typically do not exceed 20% of the Fund's net assets.

As at December 31, 2024, the Fund's most significant foreign currency exposure was to the U.S. dollar. The Fund's gross exposure as a percentage of its total net assets was 17% at the end of 2024, an increase from 15% at the end of 2023. Approximately 86% of the Fund's exposure to the U.S. dollar was hedged, increased from 80% at the end of 2023.

Our policy of hedging 100% of our U.S. dollar fixed-income exposure remained unchanged over the year. When adding currency hedges, we take into account U.S. business operations of Canadian-owned companies in the Fund.

Credit risk

The Fund invests in corporate fixed-income securities, which generally have more perceived risk than government bonds. In 2024, the Fund continued to invest about 99% of its fixed-income holdings in corporate bonds as we believe they represented better value for the Fund during the year.

Interest rate risk

The Fund's fixed-income component is affected by changes in interest rates. A bond portfolio's sensitivity to interest rate movements can be quantified by its modified duration. The higher the number, the greater the Fund's sensitivity to interest rate changes. As at December 31, 2024, the Fund's duration of its fixed-income component was approximately 1.16. In contrast, the ICE BofA Canada Broad Market Index duration was 7.43 at the end of 2024.

Results of operations**Investment performance**

For the year ended December 31, 2024, EdgePoint Canadian Growth & Income Portfolio, Series A increased by 16.4% versus an increase of 14.4% (C\$) for its benchmark, the 60% S&P/TSX Composite Index/40% ICE BofA Canada Broad Market Index. We manage the Fund independently of the indexes we use as long-term performance comparisons. Differences including security holdings,

geographic/sector allocations and the relative weighting between equity and fixed income investments may impact comparability and could result in periods when our performance differs materially from the index.

During the period, the Fund's outperformance relative to the index was primarily driven by security selection, particularly in the Energy and Financials sectors. The Fund's meaningful overweight positions in CES Energy Solutions Corp. and Fairfax Financial Holdings Ltd. contributed positively, as both delivered strong performance over 2024. Conversely, the largest detractor from relative performance stemmed from security selection in the Consumer Discretionary and Information Technology sectors. Within Consumer Discretionary, the Fund's overweight position in Restaurant Brands International Inc. weighed on returns as its share price declined. In Information Technology, while the Fund benefited from sector allocation due to its overall outperformance relative to the broader market, this was pulled back by not owning businesses such as Shopify, Inc. and Celestica Inc., both of which had a strong year. In addition, the fixed income securities within the Fund outperformed the ICE BofA Canada Broad Market Index and were an additional source of outperformance relative to the benchmark.

Please refer to the Past performance section for the performance of other series, which differ from Series A largely due to varying expenses and/or taxes incurred by each series, as explained in the Prospectus.

The blended benchmark provides a more appropriate comparison in view of the Fund's investment strategy and asset mix. The S&P/TSX Composite Index, a broad-based benchmark for Canadian equities, increased 21.7%. The ICE BofA Canada Broad Market Index, a broad-based benchmark for Canadian fixed-income securities, increased 4.1% (total returns in C\$).

With regard to the Fund's equity component, on a sector basis, the Fund's Financials and Energy holdings were the largest contributors to overall performance, whereas Utilities was the largest detractor over the period.

Meaningful contributors to investment results included:

- Fairfax Financial Holdings Ltd.
- CES Energy Solutions Corp.
- Osisko Gold Royalties Ltd.

As a group, these companies contributed approximately 7.8% to overall performance in the last 12 months.

Meaningful detractors to investment results included:

- ATS Corp.
- AutoCanada Inc.
- Dollar Tree, Inc.

As a group, these companies detracted approximately 1.3% to overall performance in the last 12 months.

While we provide these results to fulfill the disclosure requirements of this report, we measure investment success over periods of 10 years or more and believe it takes considerable skill to consistently add value over the long term.

Portfolio transactions

Portfolio turnover increased from 26.7% in 2023 to 29.6% in 2024.

Businesses purchased

Examples of companies added to the Fund include:

- Koninklijke Philips N.V. – Diversified technology company focused on lighting, medical equipment and consumer lifestyle products
- Altus Group Ltd. – Service provider for the commercial real estate industry
- Applied Materials Inc. – Supplier of equipment and services for the semiconductor and solar energy industries

Businesses sold

We generally sell a stake in a business for one of two reasons. First, if our thesis about the business is deemed no longer valid. Second, there is a constant culling process whereby we continuously strive to upgrade the quality of the Fund with better ideas.

During the period, examples of businesses sold include:

- British American Tobacco p.l.c.
- TransAlta Corp.

Portfolio composition

Sector exposure

Overall sector exposure shifted primarily as a result of investment decisions and changes in stock prices. The allocation to the Consumer Discretionary sector decreased by 1.6%, partly attributable to trimming positions in businesses, such as Mattel, Inc. and Ross Stores, Inc. It was also impacted by the share price decline in AutoCanada Inc. and Restaurants Brands International Inc., as well as selling out of Gentex Corp. The Fund's Health Care holdings increased by 1.9%, primarily due to the purchase of new businesses, including Koninklijke Philips N.V. and Roche Holding AG.

Asset mix

As at December 31, 2024, the Fund had approximately 38.4% invested in fixed-income securities and cash with the balance in equity securities, a slight change from 38.6% at the end of 2023. The Fund's cash position increased from 15.2% as at December 31, 2023 to 16.9% at the end of 2024.

Portfolio transactions are a result of our "bottom-up" stock selection process. We don't construct the Fund with an index or benchmark in mind. As a result, the Fund's composition is typically very different from its benchmark index. Our approach to portfolio construction focuses on the quality of the constituent businesses and minimizing the possibility of permanent loss of capital. Although we keep macro-level market issues in mind, they aren't a primary driver in our investment process.

Fixed-income component

We remain primarily invested in corporate fixed-income holdings, as we believe the risk-return potential for corporates is more attractive than for government debt.

Income, fees and expenses

The management expense ratio ("MER") has stayed relatively flat for all series of units of the Fund. This is a result of the Fund's growth and a continued focus on reducing operating expenses. Our goal as it relates to MERs has always been to be among

the lowest-cost fund providers in our distribution channel. We believe that we've already accomplished this with potential room to lower costs even more. Please refer to the *Financial highlights* section for more information about MERs for all series of units.

The overall change in income, operating expenses and net assets attributable to unitholders of redeemable units over the prior period is a result of a change in the Fund's size and the overall composition of businesses in the Fund.

Unitholder activity

During the year ended December 31, 2024, the Fund's net assets attributable to unitholders of redeemable units ("NAV") increased to \$3,051.4 million from \$2,499.5 million as at December 31, 2023. Of this increase, \$ 440.3 million is attributed to a gain from operations and \$111.6 million from net inflows to the Fund.

Recent developments

Between December 2023 and December 2024, Canada's annual inflation rate decreased from 3.4% to 1.8%, aligning with the Bank of Canada's (BoC) 2% target. In response, the BoC implemented 175 basis points in interest rate cuts, bringing the policy rate to 3.25% by the end of the year. These reductions raised concerns about overheating in certain sectors and the sustainability of growth. Adding to this uncertainty, the prospect of U.S. tariffs on Canadian imports raised fears of economic strain on export-reliant industries, potentially complicating Canada's future monetary policy decisions.

At EdgePoint, we avoid making predictions on the direction of interest rates, inflation or other macroeconomic variables, as we do not believe it is an area where we have a competitive advantage. Instead, we remain committed to our time-tested investment approach, focusing on developing proprietary insights around businesses we invest in.

The Government of Canada 10-year bond yield closed 2024 at 3.23%, a slight increase from 3.11% at the start of the year. This rise occurred despite the BoC interest rate cuts throughout the year. Rather than trying to predict interest rate movements or adjusting our duration exposure based on market trends, we focus on conducting detailed credit analysis for every business we lend to. When making credit investments, we view ourselves as business owners lending to businesses, we believe this approach provides us with a competitive advantage, making credit risk a type of risk we are comfortable taking.

We remain excited about the fixed-income and equity investments within the Portfolio.

Related parties

Manager

The Fund is managed by EdgePoint Wealth Management Inc. ("EdgePoint"). As Manager, EdgePoint provides (or arranges for) investment management, distribution, marketing and promotion of the Fund. As compensation for providing these services, EdgePoint receives a monthly management fee based on the daily average NAV of each series of the Fund (see *Management fees*).

EdgePoint is also responsible for the Fund's day-to-day operation. EdgePoint will often incur, on behalf of the Fund, costs associated with the Fund's operations including, but not limited to, legal fees, custodian and safekeeping fees, audit fees, administrative and operating costs, including commissions, brokerage fees, trustee fees, taxes, registrar and transfer agency fees, unitholder servicing costs, the costs of preparing and distributing annual and semi-annual reports, prospectuses, statements and investor communications, regulatory filing fees, fees and expenses payable in connection with the Independent Review Committee ("IRC"), interest and other general operating expenses that could include allocated salaries, overhead and other costs directly related to the Fund's operations. These services are in the normal course of operations and are charged at the rate agreed to by the parties. EdgePoint is entitled to be reimbursed by the Fund for these operating costs.

The management fees payable by Series I unitholders are negotiated and paid directly by them. Operating expenses for Series I unitholders are EdgePoint's responsibility and are not charged to the Fund.

Investment Advisor

EdgePoint Investment Group Inc. ("Investment Advisor") is the Fund's portfolio advisor. The Investment Advisor is entitled to be reimbursed by EdgePoint for certain operating expenses associated with its advisory services, which are paid by EdgePoint with the fees received as Manager. The Fund is not separately charged for the services of the Investment Advisor.

Independent Review Committee

EdgePoint has appointed an Independent Review Committee ("IRC") consisting of three independent members and established under the Canadian Securities Administrators' National Instrument 81-107. The IRC's mandate is to review and provide input on EdgePoint's written policies and procedures that pertain to conflict of interest matters with respect to EdgePoint-managed funds, including EdgePoint affiliates. Additional information about the IRC is available in the Simplified Prospectus and Annual Information Form for the Fund. IRC members receive fees and reimbursement of expenses for services provided to the Fund.

Mr. Joseph Shaw's term on the IRC ended effective December 31, 2024. Effective January 1, 2025, existing IRC member, Mr. David Cohen, replaced Mr. Shaw as Chair and Ms. Patricia Weir was appointed as a new member.

Other

EdgePoint provided start-up investment capital to the Fund and sufficient initial capital to each of its series to permit them to be valued on a daily basis. EdgePoint's investment in the Fund is recorded at the NAV per unit of each series, as applicable. From time to time, EdgePoint may provide the initial capital required on the introduction of a new series to the Fund.

Management fees

As compensation for the services provided, EdgePoint, the Manager of the Fund, receives a monthly management fee based on the daily average NAV of Series A, Series A(N), Series AT4, Series A(N)T4, Series F, Series F(N), Series FT4 and Series F(N)T4. Management fees for Series I are negotiated and paid directly by unitholders and not by the Fund.

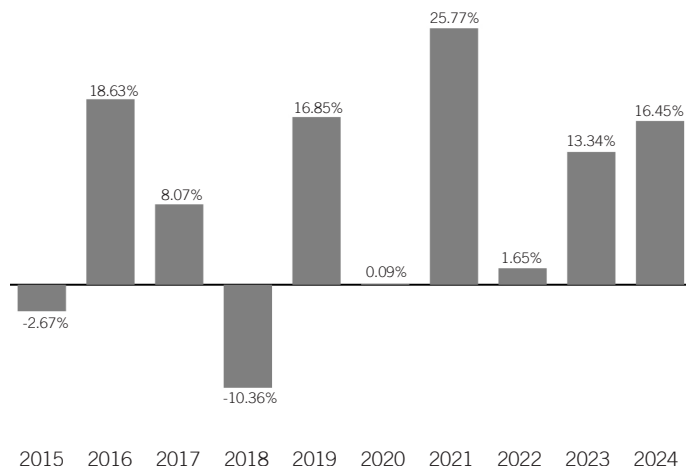
Past performance

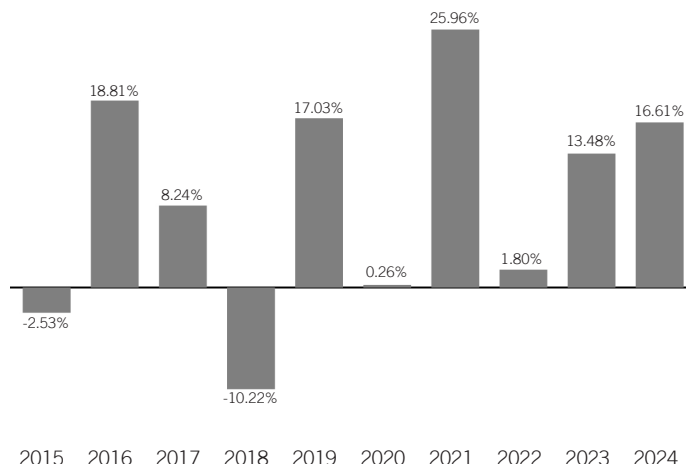
Year-by-year returns

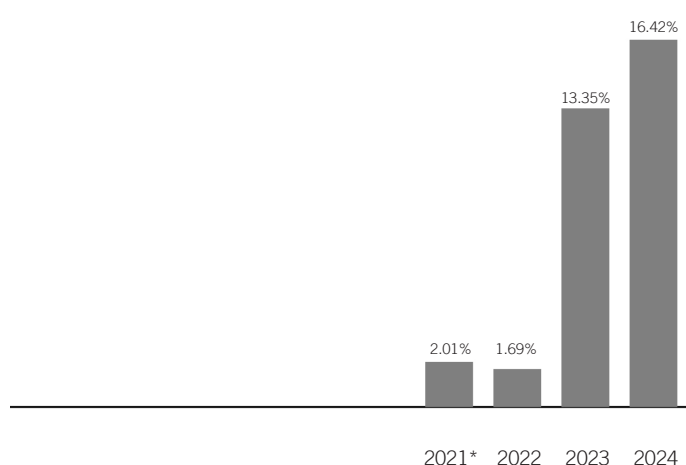
Series A



Series A(N) Non-HST

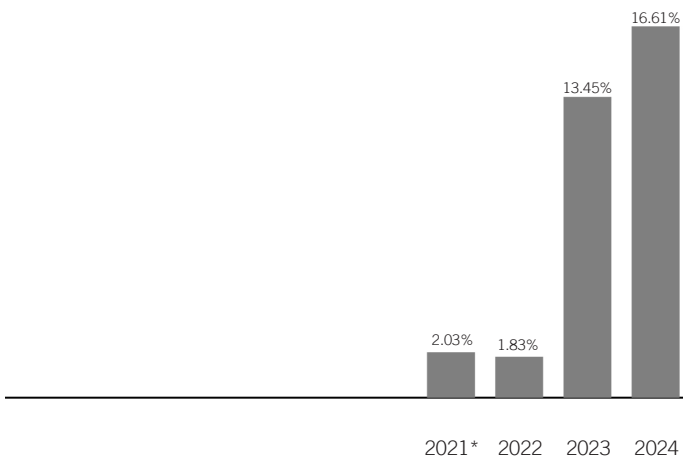


Series AT4



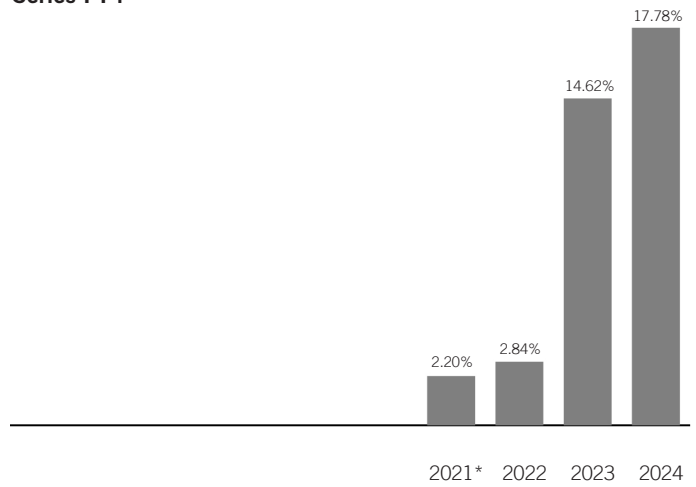

Series A(N)T4



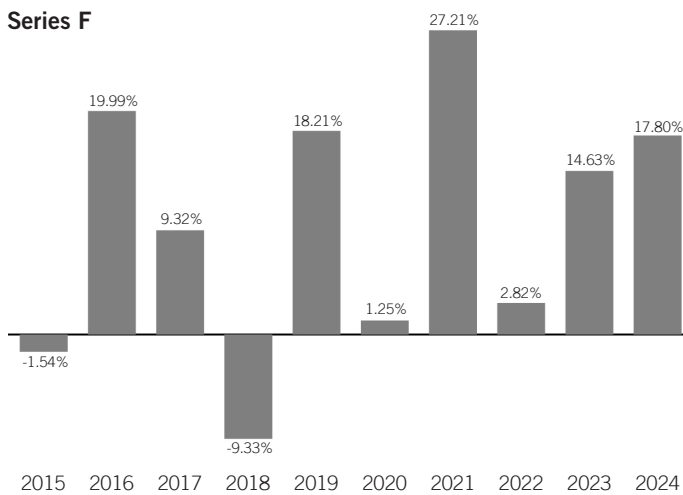

Series FT4

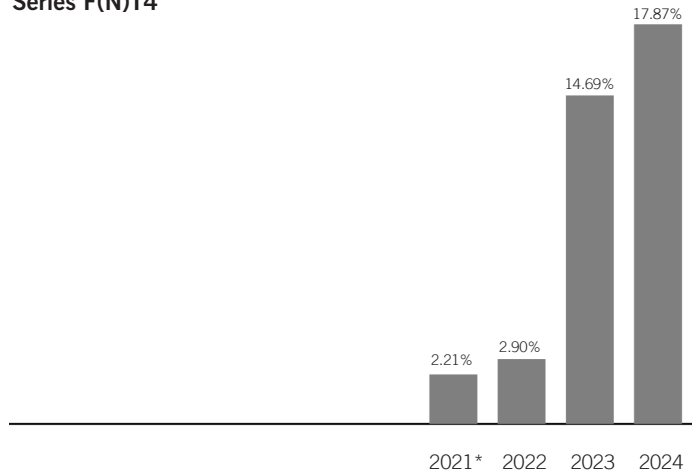

Series F

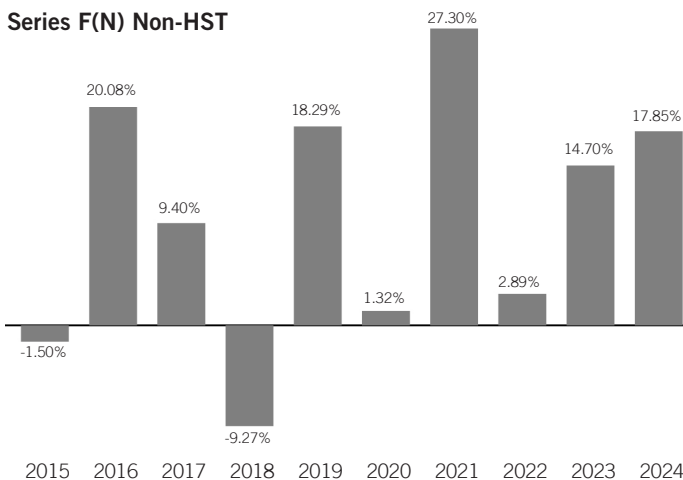


Series F(N)T4

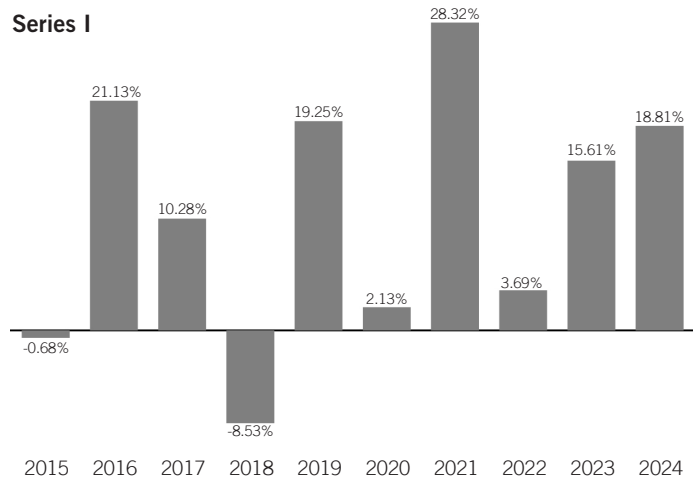

Benchmark

The Fund uses a blended index made up of a 60% weighting in the S&P/TSX Composite Index and a 40% weighting in the ICE BofA Canada Broad Market Index as a broad-based benchmark for long-term performance comparisons. The indexes are not investible.

The S&P/TSX Composite Index is a market-capitalization-weighted index comprising the largest and most widely held stocks traded on the Toronto Stock Exchange. The ICE BofA Canada Broad Market Index, tracks the performance of publicly traded investment-grade debt denominated in Canadian dollars and issued in the Canadian domestic market.

While the Fund uses these indexes for long-term performance comparisons, it is not managed relative to the composition of the indexes. There are differences which include security holdings, geographic and sector allocation which impact comparability. Additional factors such as credit quality, issuer type and yield may impact fixed-income comparability. As a result, the Fund may experience periods when its performance differs materially from the indexes. Please see the *Results of operations* section for a discussion of recent performance results.

Annual compound returns
