

## **Conditions of use of [www.virk.dk/rut](http://www.virk.dk/rut)**

These conditions of use shall apply for use of [www.virk.dk/rut](http://www.virk.dk/rut), including ordering extracts as well as subscription solutions.

1.1. [www.virk.dk/rut](http://www.virk.dk/rut) means the entire [www.virk.dk/rut](http://www.virk.dk/rut), i.e. all websites, including both front-end and back-end, which can be considered as part of the [www.virk.dk/rut](http://www.virk.dk/rut) website.

1.2. The RUT register means the Register of Foreign Service Providers (*Registret over Udenlandske Tjenesteydere*) established by Consolidating Act no. 256 of 25 March 2011 on stationing employees etc. abroad, as amended by Act no 611 of 12 June 2013.

1.3. Information can be obtained through individual searches in the RUT register, by ordering extracts, or through a subscription solution.

## **2. General**

2.1. [www.virk.dk/rut](http://www.virk.dk/rut) is owned and operated by the Danish Business Authority.

2.2. [www.virk.dk/rut](http://www.virk.dk/rut) provides access to information on foreign enterprises which, with or without employees, carry out temporary services in Denmark as stipulated in the legislation above.

2.3. The User shall be responsible for ensuring that the User's hardware and software support use by the User of [www.virk.dk/rut](http://www.virk.dk/rut).

## **3. Acceptance of these conditions of use**

3.1. Any User who uses [www.virk.dk/rut](http://www.virk.dk/rut) shall accept the conditions of use of [www.virk.dk/rut](http://www.virk.dk/rut) unconditionally.

3.2. The User shall register an email address when ordering extracts.

## **4. Obligations of the User and cessation of use**

4.1. The User shall use [www.virk.dk/rut](http://www.virk.dk/rut) in accordance with these conditions of use as well as relevant legislation.

4.2. Use of data from the Register of Foreign Service Providers for commercial purposes or in a commercial context is not permitted. This means any form of sale, advertising or similar which is not authorised by law, regulations issued in pursuance of law, or consent.

4.3. The Danish Business Authority is entitled to exclude Users from [www.virk.dk/rut](http://www.virk.dk/rut) in the event that Users use information from [www.virk.dk/rut](http://www.virk.dk/rut) in contravention of these conditions of use and legislation.

4.4. In the event that the User fails to comply with these conditions of use, the Danish Business Authority shall be entitled to block the User's access to [www.virk.dk/rut](http://www.virk.dk/rut). The User shall be liable under the general rules of Danish law.

4.5. If the User demonstrates behaviour which indicates that automatic or extensive systematic data collection from [www.virk.dk/rut](http://www.virk.dk/rut) is being carried out (irrespective of the number of searches), the Danish Business Authority reserves the right to close said User's access.

4.6. If user access is closed on the basis of points 4.4 and 4.5, in general access cannot be reopened. The Danish Business Authority will conduct individual assessments of whether user access can be reopened.

## **5. Amendments to the conditions of use**

5.1. The Danish Business Authority may amend these conditions of use at any time. If the User continues to use [www.virk.dk/rut](http://www.virk.dk/rut) after the current conditions of use have been amended on this page, the User thereby approves said amendments.

## **6. Choice of law and legal venue**

6.1. Any dispute between parties shall be subject to Danish law and shall be brought before the Copenhagen Maritime and Commercial Court, if the dispute belongs under the jurisdiction of the Copenhagen Maritime and Commercial Court. Copenhagen shall be the agreed legal venue.
