

Our reach is immeasurable yet profound.



# Highlights 2023

- After 38 years of service, Bernie Rochford, Esq., retired as Executive Vice President of Administrative Services
  and Business Relations. Bernie was hired for Oriana House's first residential community corrections program.
  During his tenure, he helped guide the agency's expansion of services through cultivating relationships with
  government and business leaders, community and professional partners, referral sources, and neighbors.
  Bernie was an integral part of Oriana House's growth of eight staff when he joined to more than 800 when
  he retired.
- The American Correctional Association (ACA) gave perfect audit scores to five Oriana House facilities. The Electronic Monitoring Program, the Community Alternative Sentencing Center (CASC), Terrence Mann Residential Center (TMRC), Residential Institutional Probation (RIP), and Special Housing Adjustment Residential Program (SHARP) were reaccredited by the ACA and each received a 100% audit score.
- Aramark expanded its In2Work program in more Summit County facilities. Clients can participate in handson food service training with the final phase culminating in a test for the ServSafe certification from the
  National Restaurant Association. Graduates have the opportunity to apply for positions available through
  Aramark, and Aramark also offers scholarships to graduates.
- The Terrence Mann Residential Center (TMRC) was honored to receive the Ohio Department of Rehabilitation and Correction Cliff Skeen Award. The award is given in recognition of excellence in community corrections.
- Rigel Recovery Services obtained funding from the HEALing Communities Study to expand and enhance our behavioral health services in Norwalk. As a result, Rigel Recovery Services moved to a new location in Norwalk which offers much more needed space.
- Seneca County Pretrial began in our North Central Ohio region to provide supervision of defendants charged with a felony while awaiting disposition of their case. Pretrial services work to assure compliance with the conditions of bond requirements and release from the Seneca County Jail.
- Megan Testa, M.D., the consulting psychiatrist for the Cuyahoga County Diversion Center, was presented
  with the Judges and Psychiatrists Leadership Initiative's Judge Goss Award. This prestigious award recognizes
  Dr. Testa's commitment to getting behavioral health services to individuals involved in the criminal justice
  system.
- Oriana House Cognitive Skills and SCOPE Manager Nyisha Stewart, Ph.D., received the Ohio Community Corrections Association's Leadership Award.
- Oriana House's Fannie M. Lewis Community Corrections and Treatment Center (CCTC) received MidTown Cleveland's Community Partner Award. The award is in recognition of Oriana House providing MidTown with dedicated volunteers while working alongside MidTown's staff, community members, and partners.
- The Washington County Pre-release Program was implemented through a \$750,000 Bureau of Justice Assistance Planning Grant. The voluntary program provides reentry support services to people sentenced to the Washington County Jail. The three-year grant allows Oriana House to offer pre- and post-release reentry services to Washington County residents while they are serving a sentence for a misdemeanor or felony conviction.
- Oriana House received a \$1,125,000 grant from the U.S. Department of Justice to create the COACH Program
  (Coaches Operating Alongside Clients for Healing). COACH provides substance use disorder treatment
  services to felony pre-trial offenders starting when they are in the Summit County Jail or the Community
  Alternative Sentencing Center (CASC) in Akron and then throughout the outcome of the pending charges.
