Oriana House staff are a part of these changes. Our staff begin work each day knowing they are helping people overcome barriers; they go home every day knowing they are changing lives.

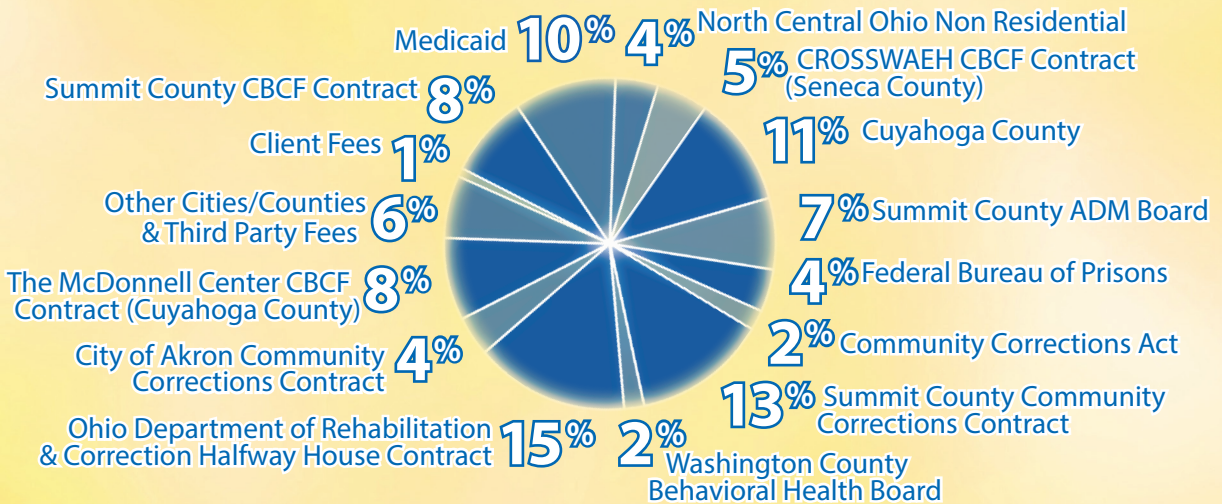
We are honored to work alongside our community partners, volunteers, and community leaders who all realize the value of rehabilitation, substance use treatment, and mental health services.

And we are proud to be a part of the changes that begin in our clients' lives and, in a ripple effect, create benefits that far exceed this present time.

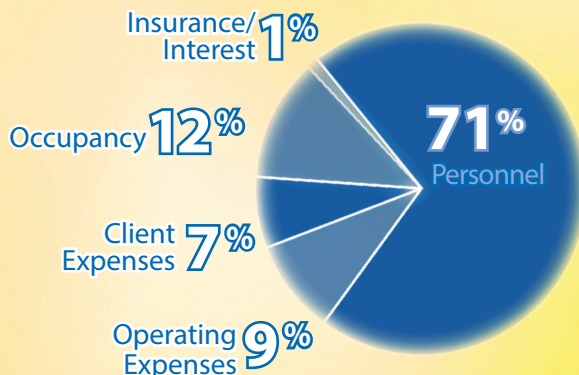

# Highlights 2022

**Oriana House expanded its Executive Staff.** Amy Corrigan Jones, Esq., was named Vice President of Behavioral Health. Prior to coming to Oriana House, Amy served ten years as a Summit County Common Pleas Judge. Molly Gauntner, LPC, LCDC III, was named Vice President of Correctional Programs in Cuyahoga County. Molly has extensive leadership, administrative, and direct provider experience in correctional services in Cuyahoga County, Franklin County, and throughout Ohio.

**The American Correctional Association gave perfect audit scores to four Oriana House facilities.** The Fannie M. Lewis Community Corrections and Treatment Center, CROSSWAEH Community Based Correctional Facility (CBCF), McDonnell Center CBCF, and Oriana House Reserve Center all received a 100% on their reaccreditation audits.

**Ohio Department of Rehabilitation and Correction provided funding for 450 tablets for client use.** The tablets use a wireless, encrypted network that allows clients to access apps for needed services such as bus routes, government sites for information pertaining to benefits, the BMV, Social Security, etc. Clients can also view apps to supplement required programming and for services related to employment and education.

**The Department of Justice Bureau of Justice Assistance awarded Oriana House \$750,000** to provide reentry support services to people sentenced to the Washington County Jail. Reentry services support a successful return to the community by addressing factors that lead to involvement in the criminal justice system. Funds from this grant were used to engage people in treatment for substance use and mental health needs and assist them with finding housing, employment, or educational opportunities.

**The Participating in Victory of Transition (PIVOT) Drug Court was awarded a \$750,000 enhancement grant** from the Department of Justice Bureau of Justice Assistance. PIVOT proposed to enhance services to 160 participants by providing clients with the opportunity for evidence-based, cognitive employment curriculum to increase job readiness and reduce barriers to obtaining employment as well as hiring specialists to work with local agencies to increase job placement. The specialists also assist clients with securing safe, sober housing and reducing the barriers faced in a rural community with limited housing options.

**The Ohio Department of Health awarded a nearly \$1,000,000 grant** to provide mitigation equipment in the Summit County Community Based Correctional Facility and halfway houses to help prevent the transmission of COVID and other communicable diseases. This included TSA body scanners and hand held sensors that can help reduce the need for client pat downs, walkie talkies, and additional PPE.

**Seneca County contracted with Oriana House to provide probation services.** Operating in Seneca County since 1999, Oriana House was selected because of experience and established local involvement. The contract funds six probation officers, an administrative assistant, a part time chief probation officer, and a liaison.

**Oriana House clients helped build a playground** with the City of Akron and Kaboom, a national nonprofit organization. Clients were able to participate as part of either required or voluntary community service. The clients' assistance with the playground build went so well that it led to other volunteer opportunities with Kaboom.

**Virtual courtrooms became operational in Summit County community corrections programs** allowing clients to attend court proceedings without leaving an Oriana House facility. This technology facilitates court appearances, improves client compliance, and helps alleviate the common barrier of transportation.

**Oriana House became involved in the UniteOhio project** that is a referral platform to connect clients to various agencies throughout the state. This allows multiple providers to seamlessly connect individuals to beneficial resources that assist with the successful transition back to the community.

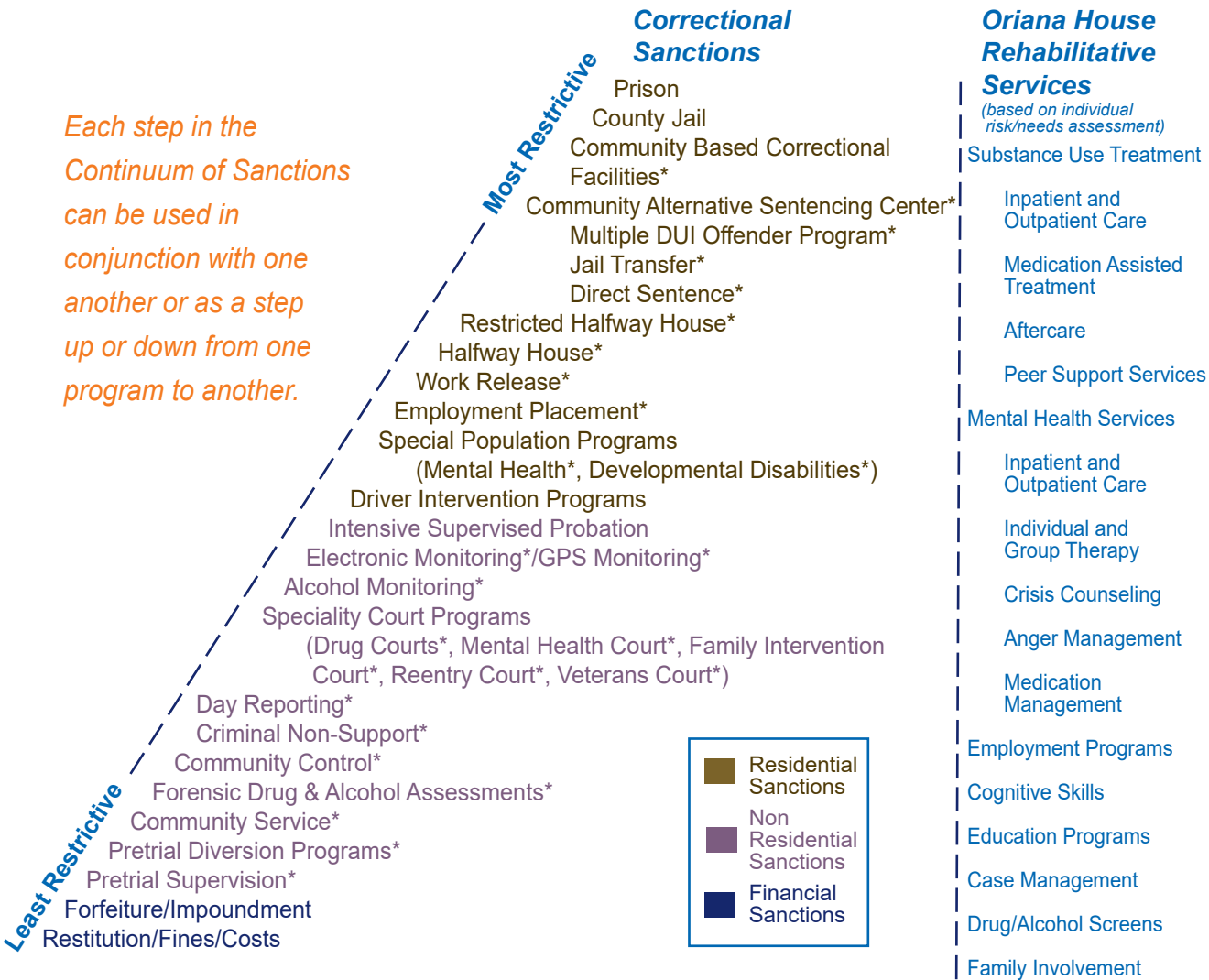


# Continuum of Sanctions Model

Oriana House provides integrated rehabilitative services across the continuum of sanctions. This continuum of sanctions is a nationwide model for successful community corrections programs.

Because many of the services are provided by Oriana House, offenders can easily be moved up and down the continuum, adding or removing restrictions as necessary, without interruption to programming.
