We will continue to open doors for our clients and work to end the revolving door of incarceration and addiction.



# Highlights 2021

Executive Vice President of Operations Anne Connell-Freund retired from a successful 32-year career at Oriana House. Anne was responsible for overseeing the operations and management of residential, non-residential, and diversionary community corrections programs and treatment for substance use disorders. During Anne's tenure, she helped lead Oriana House through the nation's opioid epidemic and expand its footprint from Summit County to include facilities located in Cuyahoga, Erie, Huron, Sandusky, Seneca, Stark, and Washington counties which provide services well beyond those counties. Michael Randle was promoted to Executive Vice President of Operations.

The Cuyahoga County Diversion Center opened as a first of its kind, 50 bed facility for people in crisis from mental health and/or substance use. The Diversion Center provides an alternative to incarceration for people living with mental illness and/or substance misuse who have an interaction with law enforcement following a low-level, non-violent offense. Referrals can also come from friends, family members and individuals who want care for a mental illness and/or substance use disorder. Services can include assessment, medical evaluation, case management, counseling, medications, medication assisted treatment (MAT), withdrawal management (detox), The National Alliance on Mental Illness (NAMI) educational groups; and referral and linkage to other community services. Oriana House operates the Center with the Alcohol, Drug Addiction and Mental Health Services (ADAMHS) Board of Cuyahoga County providing planning, management, and oversight. FrontLine Services screens for admittance.

Staff from the Greater Cleveland Regional Transit Authority (RTA) volunteered their time and talent to transform an outside area at the Cuyahoga County Diversion Center into a beautiful, calm space for clients to enjoy. Lowe's in Bedford Heights donated flowers and plants for the project, and RTA staff worked to beautify the area.

Rigel Recovery Residential Center (RRRC), which provides residential behavioral health treatment in Washington County, expanded services and moved to a new location. The 9,375 square foot location allows for comfortable living during the average 30-90 day stay. Services for men and women include substance use disorder and mental health assessments; MAT; individual and group counseling; prescribing and managing medications; case management to assist with following a treatment plan, establishing housing, education, employment, and more; guided meditation/reflection to focus on thoughts and behaviors associated with recovery; aftercare; and information and support for families through the program Family Matters.

Rigel Recovery Services in Summit County began the Partial Day Hospitalization program (day programming) which allows clients to participate in a full day of substance use treatment on an outpatient basis. Core groups, recovery coaching, mental health treatment, individual counseling, and MAT are all available for clients as needed.

Aramark's In2Work program began at the Summit County Community Based Correctional Facility (CBCF) which is operated by Oriana House. Interested clients can participate in hands-on food service training. The final phase culminates in a test for the ServSafe certification from the National Restaurant Association. Kent State University's Department of Sociology partnered with Oriana House to see if In2Work will meet evidence-based practices. This research partnership is tracking clients once they leave the CBCF to determine if they find and maintain employment and do not recidivate within three years.

The ADAMHS Board of Cuyahoga County honored Oriana House with the Helping Hands award in recognition of hosting public COVID vaccination clinics at Oriana House Hough Center. The community clinics were run by the Cleveland Department of Public Health.

Oriana House's Residential Correctional Center, the Summit County CBCF, and Cliff Skeen CBCF scored 100% on their reaccreditation audits by the American Correctional Association.

Oriana House began providing Electronic Monitoring services for the Ohio Department of Developmental Disabilities (DODD). DODD serves some individuals who are mandated by the courts to wear a GPS device.
