Message to the Community


2020 was a year like no other. Oriana House was thrown into the thick of a pandemic like every other business worldwide, and staff responded in extraordinary ways to continue to provide services while keeping clients and colleagues safe. As a behavioral health and community corrections agency, Oriana House is an essential business. We continued our operations in unprecedented ways as nearly every aspect of our work changed overnight.

Committees were immediately tasked with working through the many layers of operating safely during a pandemic. We were challenged to find personal protective equipment; increase sanitation throughout every facility; determine ways to social distance in our facilities while still providing programming; isolate and quarantine clients when necessary; and provide ongoing COVID-19 testing. Health and safety were at the forefront of every decision.

Our staff worked through the many emotions clients and their loved ones experienced during the early stages of the pandemic. Loved ones were concerned. Residential clients saw changes to their programming including little to no community access.

Court systems throughout the state responded by delaying pending court cases which led to fewer people being referred to our programs. For those who were in our programs, they continued to benefit from ongoing behavioral health services, cognitive programming, educational services, and case management.

I am incredibly proud of our staff at Oriana House. They are resilient in the face of crisis. We will continue to be here to help those who suffer from substance use disorders, need mental health care, or can benefit from our community corrections programs. We are committed to our mission and committed to changing lives.

Highlights 2020

Oriana House initiated a full-scale response to the COVID-19 pandemic. Daily meetings occurred to address protecting client, staff, and community safety while continuing to provide behavioral health services and community corrections programming. Issues such as communication with health departments; personal protective equipment; virus testing, isolation and quarantining; reducing client census; reconfiguring physical locations to allow for social distancing; and implementing new or revised procedures were addressed.

Technology enhancements helped to engage clients in programming. Many IT enhancements were promptly made across the agency so staff could use telehealth to provide vitally needed counseling for behavioral health needs. Virtual technology was also used for caseworker and court sessions; client/family visitation; client employment interviews and participation in job fairs; client education; and more.

A Diversity, Equity, and Inclusion Committee was formed resulting in increased input and activities supporting Oriana House's commitment to justice and equality for everyone.

Oriana House's Rigel Recovery Services opened an office in Woodville, Ohio to provide additional behavioral health services in the North Central Ohio region.

Behavioral health services expanded with Oriana House offering mental health services in our Cuyahoga County and Summit County regions.

The Partial Hospitalization Program (PHP) started in Summit County. PHP, or a 2.5 level of care, offers a weekly minimum of 20 hours of intensive programming. Clients who have co-occurring conditions, such as mental illness and a substance use disorder, may benefit from these more intense services that are offered in a structured environment with close supervision and recovery support.

A Quick Response Team (QRT) formed in Huron County to visit homes of individuals who have recently overdosed, providing support and resources. Follow up calls and visits offer ongoing support. QRT is a result of collaboration between law enforcement; behavioral health providers, including Oriana House; Certified Peer Supporters; and the Huron County Board of Mental Health and Addiction Services.

The American Correctional Association (ACA) awarded 100% to several Oriana House programs. The Community Alternative Sentencing Center, Electronic Monitoring, Terrence Mann Residential Center (TMRC), Residential Institutional Probation Program (RIPP), Special Housing Adjustment Residential Program (SHARP), and the Glenwood Halfway House all received 100% on their accreditation audits.

Oriana House clients earned their Commercial Driver's License. Oriana House partnered with the Summit County Think Tank Coalition and Stark State College to start a Commercial Driver's License Pathway Program for individuals with felony convictions. The program trains clients to be eligible for employment that pays a living wage, providing a way out of the criminal justice cycle while also linking them to higher education.

Oriana House clients participated in writing workshops to assist in the creation of a mural. The Mercy Mural was installed on the Fannie M. Lewis Community Corrections & Treatment Center in Cleveland. The mural was commissioned by Building Bridges Arts Collaborative and additional donors, created by local artists, and birthed from the interviews, writings, and insights of at least 30 clients.

Transitional Shelter Program started to provide up to 90 days of housing for people released from prison who are homeless.

Several programs relocated following the purchase of a building in Akron. Day Reporting, Transitional Services, Reentry Court, Family Intervention Court, Valor Court, and Criminal Nonsupport programs moved from the St. Hedwig campus to the Furnace Street building. Treatment staff moved from an office on North Main Street in Akron to the St. Hedwig campus.

Project Beginnings, an 11-unit housing program in Akron, was transferred to Tarry House, Inc. Tarry House is a nonprofit agency in Summit County that provides housing and services for those with mental illness.


