In 2018, the regional health plan, Health New England, extended virtual care services to its Medicare Advantage and Managed Medicaid populations. Little did the leadership team know at the time that virtual care was about to become a vital healthcare option.




Establishing a new normal

Health New England's initial spike in adoption and utilization of virtual care was attributed to increased word-of-mouth marketing and a data-driven engagement strategy that targeted the unique needs of the Medicare and Medicaid populations.

Those high utilization levels were then sustained in the wake of COVID-19. And although social distancing and shelter-in-place orders have been lifted, the shift to virtual care as an initial entry point into the healthcare system will forever transform how Medicare and Medicaid members seek and receive care.
