## BWW National Chicken Wing Day "Free Wings For A Year" Sweepstakes

Official Rules, Terms and Conditions

- (1) NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO PARTICIPATE OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE ELIGIBILITY AREA (AS HEREINAFTER DEFINED) AND WHEREVER PROHIBITED OR RESTRICTED BY LAW.
- (2) Eligibility: BWW National Chicken Wing Day "Free Wings For A Year" Sweepstakes (the "Sweepstakes") is open to all legal residents of the United States (including D.C.) (the "Eligibility Area"), 18 years of age or older as of 07/29/2022 (each an "Entrant"). Employees of Buffalo Wild Wings, Inc. ("BWW" or "Sponsor") and its parent, affiliated and subsidiary companies, and members of the immediate families (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside), and/or those living in the same household, of any of the foregoing are not eligible (the "Released Parties"). - (3) Sweepstakes Period: The Sweepstakes begins at 12:00:00 AM Eastern Time ("ET") on July 29, 2022 and ends at 11:59:59 PM Pacific Time ("PT") on July 29, 2022 (the "Sweepstakes Period").
- (4) To Enter: In order to participate, you must be enrolled in BWW's Blazin' Rewards program as of 07/29/2022 and enter by checking-in, via the BWW mobile app, while at a BWW restaurant (an "Entry").

Participants may only enter the sweepstakes only once. Multiple entries will be removed from the potential pool of entrants, but the original entry will be kept. Multiple Entrants are not permitted to share the same email address. Incomplete Entries, Entries generated by script, macro or other automated means, or Entries that do not fully comply with these Official Rules, or Entries which subvert the entry process, in the sole discretion of Sponsor, will not be eligible. Proof of submission of Entry does not constitute proof of delivery or Entry during the Sweepstakes Period. All Entries become the exclusive property of Sponsor and will not be acknowledged. In the event of any dispute concerning the identity of any Entrant, the relevant Entry will be deemed submitted by the authorized account holder of the email address associated with the Blazin' Rewards account used to submit the Entry and such individual must comply with these Official Rules. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

(5) Winner Selection, Notification & Prize Claiming: On or about three (3) business days after the Sweepstakes Period has ended, Sponsor, through an independent judging agency, will conduct a random

prize drawing (the "Drawing) from among all eligible Entries received in order to select one (1) potential grand prize (the "Grand Prize"):

• Grand Prize: One (1) Grand Prize winner will receive Free wings for a year awarded as fifty-two (52) digital offer certificates (one each week) via Blazin' Rewards, each valid for one order of 6-wings (boneless or traditional) at participating BWW restaurants. Does not include delivery fees. Offer certificates must be used within seven (7) days of issuance. Unused certificates will expire and not be replaced. (Total ARV: \$500).

In no event will Sponsor be responsible for awarding more than the stated number of Prizes herein.

Sponsor will notify winner by e-mail. By entering, Entrants give their express permission to be contacted by Sponsor by email and/or phone. Winner must respond to initial notification within three (3) days of the date of notification or Grand Prize will be forfeited and an alternate winner will be selected. Winner may be required to sign and return an Affidavit of Eligibility and Release within ten (10) days of notification in order to receive the prize. In the event of noncompliance with these requirements, the prize will be forfeited and an alternate winner may be selected. If prize notification is returned as undeliverable, the prize will be forfeited and an alternate winner will be selected. Unclaimed prizes may not be awarded.

Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If any part of these Official Rules is determined to be invalid or unenforceable pursuant to applicable law including, but not limited to, the warranty and liability disclaimers set forth herein, then the invalid or unenforceable provision will be deemed superseded by a valid, enforceable provision that most closely matches the intent of the original provision and these Official Rules shall continue in effect. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MASSACHUSETTS OR NEW HAMPSHIRE. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN FULTON COUNTY, GEORGIA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
