#### CALCULATING THE PRICE OF BITCOIN ZERO



We calculate the arithmetic mean price from four major exchanges<sup>1</sup>



Using market rates, we convert the dollar value of BTC (BTC/USD) into the product currency (SEK)



We apply the multiplier 0.0001 to set the price of one certificate, making it an affordable unit price

<sup>1</sup>The reference price is set using the average price of the underlying (BTC/USD) from the four most liquid exchanges (currently Bitfinex, Bitstamp, Coinbase, and Kraken). The exchanges used may vary depending on their trading volumes.
