1.	Welcome and announcements	
1.1	Jane Stewart (JS) from LCA Planning welcomed all to the ATF and	
	introduced the agenda. Attendees introduced each other as JS	
	and Duncan Ayles (DA) from LBN were new to the Forum.	
1.2	Tim Halley (TH) from LCA and Susan Watt (SW) from TfL sent their	
	apologies.	
1.3	TH asked JS to stand in as the meeting Chair because he was	
	unable to attend on this occasion.	
2.	Airport Business update	
2.1	Members updated as per page 3 of the accompanying slide	
	pack.	
2.2	JS updated members on passenger numbers, which continue to	LCA
	be significantly impacted by the COVID-19 pandemic. Figures	
	show a steady increase since the summer with levels around	

	145,000 in November. Unfortunately, this growth may be	
	hampered by the new Omicron variant and the possibility of	
	further government and international travel restrictions. Passenger	
	numbers will continue to be reviewed and will be reported back	
	to the Forum at the next meeting.	
2.3	William Layton (WL) KAD asked if LCA could provide passenger	LCA
	number figures on a month basis for 2021 and 2019 to help them	
	ascertain differences in demand on the DLR. JS agreed to	
	provide the data breakdown.	
3.	Airport Operations update	
3.1	Update as per page 4-5 of the accompanying slide pack.	
3.2	JS confirmed that all Covid secure operating facilities and	
	procedures remain in place, including the temporary testing	
	facility.	
4.	Surface Access update	
4.1	Update as per page 7-12 of the accompanying slide pack.	
4.2	JS confirmed Covid-19 has continued to impact on how people	
	travel to and from the airport. Pre-pandemic (Q1 2020) the figures	
	for passengers travelling by DLR (64%) were almost on track to	
	meet the 2022 interim target of 66%. The pandemic and	
	government restrictions has resulted in Q3 2021 being 49%. WL	
	agreed that cabs were being used more often.	
4.3	JS noted that some measures and timescales outlined in the	LCA
	Travel Plan would need to be reviewed given the significant short-	
	term impacts of the pandemic. She explained that it was difficult	
	to establish any real trends due to the significantly reduced	
	passenger numbers and Covid restrictions and that data will	
	continue to be collected through 2021 and 2022 to inform these	
	discussions. This data will be reported back to the Forum.	
4.4	JS confirmed an Employee Travel Survey had been prepared to	LCA
	update the 2019 survey. Due to the ongoing pandemic this will	
	be undertaken in 2022 at a suitable time once current work from	
	home and government restrictions are lifted. It was noted that	
	the pandemic may impact trends in staff travel. The results will be	
	reported and reviewed with the Forum.	
4.5	JS advised LCA will promote the use of public and sustainable	
	transport as the UK recovers from the pandemic and will seek to	
	utilise the support of service providers to advise and reassure	
	passengers and employees public transport is Covid safe. WL	
	confirmed TfL will support getting a consistent message across to	
	encourage people back to using public transport.	
4.6	JS confirmed LCA will be monitoring the use and power needs of	LCA
	the trial electric charging points. This will inform the installation

	requirements of additional charging points with regards to energy	
	demand. Updates will be reported to the Forum.

	undertaken in 2022. JS outlined the proposed process (shown on	
	slides 11 and 12) and confirmed a transport consultancy will be	
	commissioned to facilitate and support the review. The scope of	
	the review will be presented to the Forum to agree, including any	
	appropriate topic based workshops to focus on specific issues.	
4.8	JS noted that LCA's Travel Plan is also to be reviewed in 2022 and	
	this will be informed by the ASAS review.

5.1	Richard Storer (RS) updated members that the trial operations are	
	ongoing on the Elizabeth Line with a possibility of fully opening the	
	line to passengers Q1/Q2 2022.	
6.	Open Discussion	
6.1	JS advised that TH would welcome consideration of setting up	LCA
	separate workshops on specific topics that would feed back into	
	the main Forum meetings. WL considered this would be a good	
	idea. LCA will consider the potential workshop groups for	
	discussion at the next meeting.	
6.2	JS noted that the London Borough of Newham Local Plan Refresh	
	has been published for public consultation, the closing date of	
	which was that day (17 December 2021).
