FEES AND CHARGES

2023/24

This Booklet is issued in accordance with and should be read together with the Conditions of Use Booklet for London City Airport. Terms and expressions defined in the Conditions of Use shall have the same meaning when used herein.

Effective: 26 March 2023

Premium Charges: Relate to any Aircraft which is on the Airport (from touch-down to take-off) or scheduled to be on the Airport for any part of the following periods:

0745 - 0859 inclusive Monday – Friday
1745 - 1859 inclusive Monday – Friday and Sunday

Peak Charges: Relate to any Aircraft which is on the Airport (from touch down to take-off) or scheduled to be on the Airport for any part of the following periods:

0630 - 0744 inclusive Monday – Friday
0900 - 0959 inclusive Monday – Friday
1700 - 1744 inclusive Monday – Friday and Sunday
1900 - 1959 inclusive Monday – Friday and Sunday

Shoulder Charges: Relate to any Aircraft which is on the Airport (from touch down to take-off) or scheduled to be on the Airport for any part of the following periods:

1000 - 1200 inclusive Monday – Friday
1500 - 1659 inclusive Monday – Friday and Sunday
2000 - 2030 inclusive Monday – Friday and Sunday

Off-peak Charges: Relate to all other times including Saturday, and Sunday up to 1459.

* For airlines not operating scheduled services at the Airport, the Shoulder charge will apply at off-peak times.

If an aircraft only departs from the Airport, then the full landing fee is chargeable.

6. PASSENGER LOAD SUPPLEMENT (PLS)

(including 100% Hold Baggage Screening, CUTE, and PRM charges) (per departing passenger)	24.51
For any airline failing to notify LCY in advance for more than 25% of PRM travellers, a penalty of £10 per PRM pax will be charged on every passenger above the level notified	10
Minimum charge per aircraft	1,550.44

If an aircraft only arrives at the Airport, then the PLS will be charged on arriving passengers. Where applicable this will also be applied to the Security Levy below.

8. AIRCRAFT PARKING FEES

9. EARLY ARRIVALS CHARGE

Should an aircraft touch-down between zero and 15 minutes ahead of its scheduled arrival time ("the Allowable Early Arrival Period") no Early Arrival Charge will be applied.

Should an aircraft touch-down more than 15 minutes ahead of its scheduled arrival time, the following charges will apply for each 15-minute period (or part thereof) over and above the Allowable Early Arrival Period based on the scheduled arrival time for the aircraft.

10. OUT OF HOURS CHARGES

Extension of the opening hours published in the UK Air Pilot or altered by NOTAM maybe available subject to a request in writing to an Airport Director at least 24 hours in advance of the Airport facilities being required. Where such notice is not possible, and the extension hours are due to weather, ATC or technical delays, etc., application must be made to the Operations Controller by telephone as early as possible and confirmed in writing or by email. Airport extensions are subject to the Airport planning permission in place with regard to the Airport and the availability of operation and technical staff and, where granted, will attract a surcharge.

The period to be charged for will be calculated from the promulgated closing time, or to the promulgated opening time. Each and every Operator of Aircraft out of hours will be separately charged on the following basis:
