DEADLINES FOR FEDERAL OFFICES

Nomination papers must be submitted to the Board of Registrars of Voters or Election Commissioners for the certification of names by 5 p.m., May 7, 2024.

Nomination papers with certified names must be filed with the Secretary of the Commonwealth by 5 p.m., June 4, 2024.

REQUIREMENTS

For the papers to be valid, a candidate must file the following with the Secretary of the Commonwealth, Elections Division, One Ashburton Place, Room 1705, Boston, MA 02108, 617-727-2828 or 1, 00-462-8683, by the filing deadline:

- an enrollment certificate (see box to right) signed by at least the registrars and completed on at least ONE nomination paper, and
- the candidate's written acceptance (see opposite above) to ONE paper; and
- for all candidates EXCEPT federal: a receipt from the Socie Ethics Commission (One Ashburton Place, Reom 619, Boston, M. 02108, 617-371-9500) showing that the same bashs filed a statement of financial interest with them.
