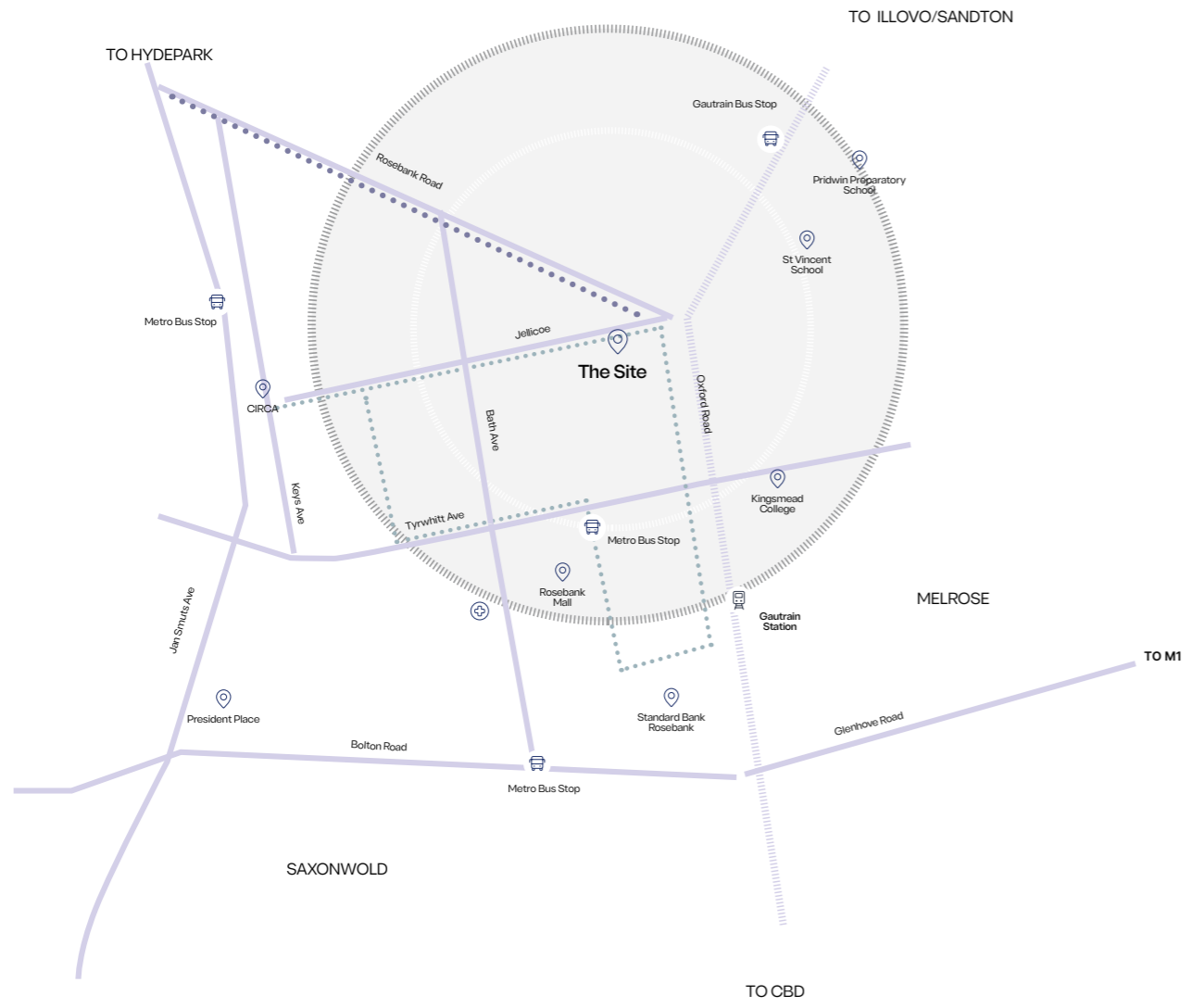
Overview

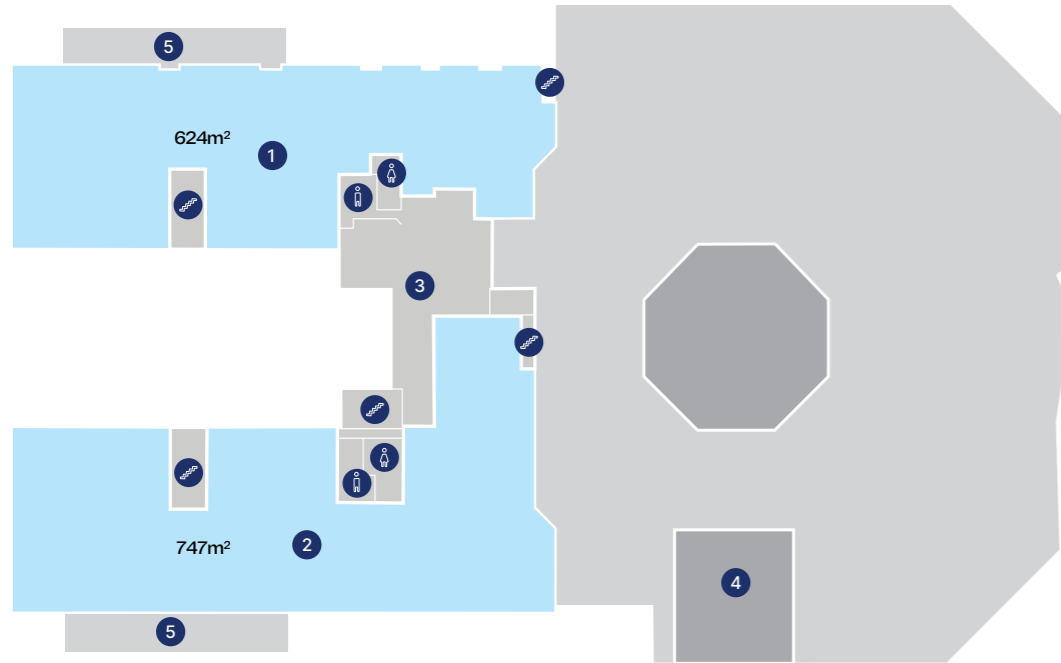

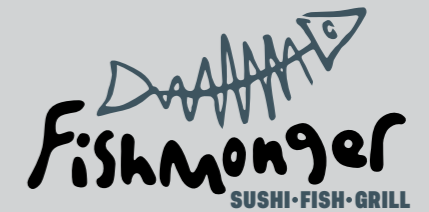
