Throughout this journey, you will benefit from mentorship by senior leaders and gain firsthand exposure to real-world challenges and creative solutions.

Fiduciary Management Rotational Program

Fiduciary Management (FM) is the bridge between clients and all parts of AIMCo. FM is comprised of Investment Strategy Research, Client Strategy & Product Management and Client Management. Each team within FM contributes to ensuring that the assets under management are invested in a way that aligns with client goals and objectives. This 18-month rotational program provides cross functional experience within FM, leverages special project work in each group of FM, as well as direct liaison with other parts of AIMCo and client experience.
