## **TNG Technology Consulting GmbH – Code of Ethics**



## My Commitment to My Clients

- 1. Integrity, competence, independence, objectivity, and professionalism: "I shall act in my clients' interest with integrity, competence, independence, objectivity, and professionalism."
- 2. Realistic expectations on services: "I shall establish, together with my clients, realistic expectations on the benefits and results of my services."
- 3. Necessary experience and competence: "I shall only accept assignments for which I possess the necessary experience and competence to perform. I shall only assign staff or confer with colleagues possessing the required knowledge and necessary expertise to serve my clients effectively."
- 4. Common understanding of the goals and scope of the work plan: "Before accepting any engagement, I shall ensure that I have established a common understanding of the objectives, scope, work plan, and fee arrangements with my clients."
- 5. Necessary handling of confidential client information: "I shall treat appropriately all confidential client information that is not public knowledge and take reasonable steps to prevent it from access by unauthorized parties. I shall not take advantage of proprietary or privileged information, either for myself or another client, without explicit permission from the client."
- 6. Conflicts of interest: "I shall avoid conflicts of interest or the appearance of such and shall immediately disclose to the client any circumstances or interests that I believe may influence my judgment or objectivity."
- 7. Offer to withdraw if objectivity or integrity could be impaired: "I shall offer to withdraw from a consulting assignment when I believe my objectivity or integrity may be impaired."
- 8. No enticement of client employees without consultation: "I shall refrain from enticing an employee of an active or inactive client to consider alternative employment without prior discussion with the client."

## My Commitment to Financial Integrity

- Prior agreement on the basis for payment: "I shall agree in advance with the client the basis for fees and expenses and shall charge fees that are wellfounded and commensurate with the services delivered and the responsibility accepted."
- 2. No personal advantage; disclosure of financial interests: "I shall not accept commissions, remuneration, or other benefits from a third party in connection with my recommendations to a client without that client's prior knowledge and consent. I shall disclose in advance any financial interests in goods or services that form part of such recommendations."

## My Commitment to the Public and the Profession



- 1. Reporting of damaging behaviour or illegal activities: "If within the scope of my engagement, I shall report to appropriate authorities within or external to the client organization any occurrences of malfeasance, dangerous behaviour, or illegal activities."
- 2. Respect for the rights of consulting colleagues and firms: "I shall respect the rights of consulting colleagues and consulting firms and will not use their proprietary information or methodologies without their permission."
- 3. Integrity and professionalism: "I shall represent the profession with integrity and professionalism in my relations with my clients, colleagues, and the general public."
- 4. Respect for others: "I will always treat the people I come into contact with in the course of my profession with respect and not discriminate against them in any way."
- 5. No misleading advertising, no maligning of the competition: "I shall not advertise my services in a deceptive manner; neither will I misrepresent or denigrate individual consulting practitioners, consulting firms, or the consulting profession."
- 6. Promote adherence to the code: "Should I become aware of a violation of the code, I shall promote adherence to the code by other employees who have committed themselves to it."
