13F Filings reveal Bitcoin ETF buyers

- The market moved sideways, with \$BTC down by -0.7% and now trading at \$70,011. Although there was a small rally during the Asian Hour fueled by positive ETF flow news, the market retraced to the \$70k level, even with better-than-expected PPI news.
- The \$GBTC outflow on 4/10 was the smallest at just \$17.5M, making the day's net flow positive at \$127.3M. However, early reports show that \$GBTC outflow is back at the usual level, with a \$124.9M outflow on 4/11.
- On the listing side, Binance listed \$TAO on its spot market, and Coinbase International Exchange announced the listing of \$PEPE perpetuals.
- Following Uniswap Labs' receipt of a Wells notice, \$UNI, \$GRT, and \$FIL were the biggest losers. Conversely, \$TAO, \$TON, and \$VET were the biggest gainers on the back of Binance listing.

13F Filings reveal Bitcoin ETF buyers


The SEC requires investors managing over \$100 million in assets to disclose their investment holdings quarterly through 13F filings. Last night, the first batch of the filings was disclosed, giving a glimpse of who's been buying BTC spot ETFs. Some are quick to spit out positive headlines ("banks are buying bitcoin!"), but caution is warranted before reading too much into the list. First, the banks may simply be holding it as a custodian. Second, the GBTC holders on the list probably don't represent fresh capital. GBTC, before the ETF conversion in Jan., was an OTC-trading business trust, which is not considered a 13F Security and therefore not subject to filing. This means the GBTC holders on the list are likely old holders from its 'business trust days.'

More importantly, this is only the first batch.

The public disclosure of 13F filings usually surfaces staggered over a period, given that different institutions submit their filings at various points up until the deadline, which is 45 days after each calendar quarter-end. Disclosures with more meaning insights are probably yet to come.


