

- The market remained quiet, with \$BTC trading at \$63,156 and \$ETH at \$2,580. ETH/BTC stands at 0.409, and BTC dominance is at 57.5%.
- During her speech at the Economic Club of Pittsburgh, Kamala Harris emphasized the need for the US to "remain dominant" in AI, quantum computing, blockchain, and emerging technologies. She underscored a commitment to fostering innovation in AI and digital assets while ensuring consumer and investor protection.
- A few project updates include Binance launching pre-market spot trading of "actual tokens," PayPal enabling US business accounts to buy and transfer crypto, and A16z making its first 'DeSci' investment in AminoChain.
- In the last 24 hours, the top three gainers were \$CELO, \$WLD, and \$BABYDOGE, while the top three losers were \$NEIRO, \$SUNDOG, and \$CFX.

Gas Price Rises: Alt Season On The Way?

The Sep 20 Daily highlighted the potential for a falling Fed funds rate to trigger a TVL recovery, driven by relatively more attractive on-chain yields. While it's too early to say this is happening, signs are emerging that some are positioning for this trend. First, ETH has outperformed BTC since the Fed's 50bp cut last week. Second, transactions on the Ethereum network have increased, causing a moderate rise in gas prices (See 'Daily Network Fees' on page 6). The spread between on-chain yields and the 3M T-bill is still wide (100 bp+ for USDC/USDT), suggesting that a full-scale on-chain migration of capital, if it happens, is more likely a 2025 story. However, with many key L1s severely underperforming BTC this year, enough people seem to be jumping in to exploit the asymmetric risk profile in the alt space.

BTC vs ETH Since Fed's 50bp Cut


















Dominance Ratio Sector Performance
























