- \$BTC climbs upward as China confirms plans to begin trade negotiations with the US. As of now, \$BTC is trading at \$96,825 and \$ETH is trading at \$1,816. Bitcoin dominance stands at 65.30%.
- India conducted missile strikes on nine terror sites in Pakistan and Pakistan-administered Kashmir, escalating tensions after a deadly attack on Hindu tourists in Indian Kashmir. Pakistan reported three deaths, denied involvement, and vowed a response, intensifying the conflict.
- A few headlines include: Scott Bessent and Trade Representative Jamieson Greer will meet with Chinese officials in Switzerland this week, New Hampshire becomes the first US state to pass a 'Strategic Bitcoin Reserve' bill (see below), and Bitwise has filed a Form S-1 with the U.S. SEC to launch the Bitwise NEAR ETF.
- During the last 24 hours, the top three gainers were \$LTC, \$SAROS, and \$GRASS, while the top three losers were \$LAYER, \$AKT, and \$VIRTUAL.


## **Bitcoin Boost, Stablecoin Block**


The crypto market faces mixed signals as legislative hurdles and state-level progress collide. Senate Democrats are stalling the GENIUS Act, a stablecoin regulatory bill, citing ethical concerns over Trump family ties to a \$2 billion crypto deal involving UAE-backed MGX and World Liberty Financial's USD1


stablecoin. Sen. Warren and Merkley warn of "potential foreign influence and constitutional violations", prompting calls for probes and additional hearings. This resistance threatens bipartisan support, with some Democrats reversing earlier backing citing insufficient anti-money laundering and security provisions. On a positive note, New Hampshire has become the first state to enact a Strategic Bitcoin Reserve law, allowing up to 5% of its \$3.5 billion state fund to be invested in Bitcoin. Signed by Governor Kelly Ayotte (R) last night, the bill aims to hedge against inflation and aligns with crypto-friendly policies under Trump's administration. With all eyes on who's next, watch Texas and North Carolina closely.












# ORDER BOOK DEPTH (within 1% best bid/ask) Coinbase BTC/USD ETH/USD









