



- \$BTC is slightly up from yesterday. As of now, \$BTC is trading at \$106,815 and \$ETH at \$2,523. Bitcoin dominance stands at 64.12%.
- The U.S. Senate has advanced the GENIUS Act—a bill regulating stablecoins—with a 66–32 cloture vote, overcoming earlier Democratic resistance tied to concerns over President Trump's crypto ventures (see below).
- A few other headlines include: Bybit now allows users to trade top global stocks directly with USDT; Ethereum co-founder Jeffrey Wilcke transferred 105,736 ETH to Kraken; and the SEC has delayed decisions on the proposed XRP and Dogecoin ETFs.
- Over the past 24 hours, the top three gainers were \$TRUMP, \$GRASS, and \$SUPER, while the top three losers were \$PYTH, \$TURBO, and \$LTC.

Senate's GENIUS Act Ignites Crypto Summer Rally Hopes

The Senate yesterday passed the stablecoin bill, humbly named the GENIUS Act, marking the first crypto bill to clear the chamber. While the House's equivalent, the STABLE Act, passed committee on April 2 and awaits a floor vote, the House Financial Services Committee is reportedly refining it to align with the GENIUS Act, targeting a vote before August. Reconciliation hinges on resolving state versus federal regulation and stricter rules for foreign issuers, with Tether's offshore status a key focus. The market appears optimistic, as seen in the 95% odds on Polymarket, albeit with low volume. If the industry's hope prevails and last-minute political maneuvering doesn't delay the process, the crypto market may be in for a summertime bull catalyst. The TradFi market should also welcome this in the long run. About \$10 trillion in Treasury debt, much of it in short-term Treasury bills, needs buyers this year. Legitimizing Treasury-bill-gobbling stablecoin issuers via legislation will help grow the sector, greatly easing supply-demand dynamics.
