- The crypto market continues to sell-off with \$BTC now trading at \$95,066 and \$ETH now trading at \$3,327. Bitcoin dominance stands at 57.91% and ETH/BTC is at 0.035.
- During a speech in Paris, Fed Governor Waller said that "I will support further cuts in 2025, but the pace will depend on further inflation progress." He mentioned that tariffs are unlikely to have a significant impact and are unlikely to influence his view.
- Few headlines include, Gary Gensler repeated his assertion that crypto is "rife with bad actors" during his Bloomberg interview, the criminal trial of Terraform Labs founder Do Kwon has been tentatively scheduled for late January of next year, and Movement Labs announced that it is about to complete a \$100 million Series B financing.
- Over the past 24 hours, the top gainers were \$AKUMA, \$FARTCOIN, and \$OM, while the top losers were \$FAI, \$POPCAT, and \$PENDLE.

## **Recalibrating for the Breakout**


As BTC remains stuck at 91K-\$102K range following the Fed's hawkish guidance on Dec. 18, the market ponders on the timing of the breakout (or breakdown). The Dec. FOMC minutes, released last night, confirm that the Trump administration and its policy implications were the main drivers of the Fed's hawkish shift. A breakout will happen when the market completes its re-calibration process and uncertainty clears. Given it took the Fed officials 5 weeks to embrace policy implications (recall the Fed had a chance to do so at Nov. 7th FOMC, a day after the election result, but instead went ahead with 25bp cut) and its thinking process is now made public, the broader market too may now be at the end of

the recalibration process, This is evident in the stable rate cut expectations seen recently, oscillating between one or two cuts this year. What's left then is when the policy uncertainty will clear. Signals for this will likely emerge after Trump's Jan. 20 inauguration and gradually take shape during his first 100 days in office. Be patient and stay tuned.


