Action
That an Official Board Policy is adopted allowing only authorized users inside Terminal Facilities, the Rental Car Facility, or in Remote and Express Parking Facilities at DFW International Airport.

Description

- DFW Airport handles high volumes of passenger traffic and is responsible for the general safety, security, and welfare of the traveling public.
- Use of the Airport terminals, terminal garages and rental car facilities will be limited to authorized users defined as arriving and departing passengers, hotel guests, persons meeting or picking up arriving and departing passengers, persons engaged in activities in which a permit has been issued by the Airport, employees and other personnel necessary for, or related to, the operation of the Airport and the rental car facilities.
- Notwithstanding this policy, the areas beyond the passenger screening checkpoints are specifically reserved for appropriately badged airport employees, ticketed airline passengers, and their authorized escorts only.

Justification

- This policy ensures that Airport facilities are available for authorized users engaged in legitimate airport activities.
- This policy grants DFW Board personnel the ability to ensure that the needs of Airport users are met and furthers its mission to provide an exceptional airport experience for customers.


