Final Settlement	<p>Trades will be cash settled to the closing price special opening quotation of the S&P/NZX 20 Capital Index value calculated by S&P using the close prices on the Last Trading Day in accordance with the S&P/NZX New Zealand Indices Methodology.</p> <p>The closing price special opening quotation will be calculated using the last first on-market traded price of each constituent in the S&P/NZX 20 Capital Index on the Last Trading Day, irrespective of when those shares first trade on the NZX Main Board during the Trading Day. This means that the first traded price of each constituent in the index may occur at any time between NZX market open and NZX market close.</p> <p>Should any constituent of the index not have traded by NZX market close on the Last Trading Day, the last traded price of that share will be used to calculate the closing price special opening quotation.</p>
