Year of Planning

The **Year of Planning** is a customized developmental process for implementing a NAF academy. Districts/schools with little or no experience designing a career-focused program receive personalized support and guided technical assistance to ensure that local programming goals align with NAF's design prior to the academy's launch. This planning phase helps to establish a sustainable foundation that fosters academic success and builds the capacity to deliver on the promises made to academy students and the community. The application fee is \$12,000.

Fast Track

The **Fast Track** process allows existing career academies implementing most NAF standards, NCAC, or Linked Learning Certified, to join the academy network with full membership benefits. The application includes gathering all necessary documentation to demonstrate that the existing career academy aligns with NAF's design, allowing them to expedite the academy's launch and receive the associated support and resources. The application fee is \$4,000. Note: The \$2,000 annual membership fee is due at the time of the academy's launch.
