As the Chairman of the board for the 2018-2019 fiscal year, I had the privilege of guiding the museum through a time of significant change and transition. Before the start of the fiscal year, long time director Debi Gray announced her retirement which meant that the year started with the difficult task of searching for her replacement. The board conducted an organized, thorough process. Through the search we found an enthusiastic former Virginia Beach native looking to return and move the organization in new directions, and in December Gary Ryan took over the job of Executive Director. She was charged by the Board of Directors and myself to accelerate the change already started under Debi Gray's tenure.

From an art perspective, the first major exhibition of the year was a MOCA organized show, *Todd Schorr: Atomic Cocktail* and it was a great success with high visitation. This exhibition is scheduled to go on to travel to the Crocker Art Museum in Sacramento California in June of 2020. I am proud to be part of a museum that not only impacts our local community, but also has a strong national reach.

The next opening was *The Rest of History* with the 2019 New Waves exhibition. Seeing museum patrons and members cut quilting letters with exhibiting artist Gina Adams to help her with her next project was not just memorable, it was an experience that I found to sit at the core of MOCA's mission and what sets us apart from your normal art museum. This was reinforced when I talked with patrons who attended a studio school master class with Charles Edward Williams, his works inspiring them to push their understanding of painting. Intimate experiences with the art of our time, while also getting to meet, learn from, and work with living artists is not just a uniquely MOCA experience, it is why I loved serving as a leader for this institution! This being my final year as Board Chair, I would like to take a moment to thank you for the honor to serve in this role for the Museum. It has been incredibly rewarding.

The future is bright for MOCA, and I look forward to seeing how far we progress!
