INSTRUCTIONS TO AUTHORS

HEALTHCARE ADMINISTRATION LEADERSHIP AND MANAGEMENT JOURNAL invites authors to submit scholarly and practical articles on topics related to inter-professional healthcare administration. HALMJ delivers indispensable and reliable, results-oriented guidance for a healthcare system moving towards inter-professional management and impact on patient outcomes. Articles are accepted with the understanding that they are not being considered for publication elsewhere and have not been published previously. The articles are subject to editorial review and revision.

Manuscript Submission. Articles must be submitted electronically. The electronic file should include a cover page with the title of the article, the names of the authors in the order they are to appear, the authors' highest degrees (limited to only two advanced degrees), and academic affiliation with complete contact information for the corresponding author (address, phone, e-mail). All text, references, figure legends, and tables should be in one double-spaced electronic Word document. Consider adding subheads to organize the article and break up large amounts of text. Figures should be transmitted separately in an editable format. Legends for all figures should be included in the file with the text and should not appear on the figures. Copyright Assignment. Upon manuscript submission, it will be necessary for American Association for Physician Leadership to receive in writing the assignment of copyright from all authors of all manuscripts. Published manuscripts become the property of *Healthcare Administration Leadership and Management Journal* and may not be reprinted without permission of the Publisher. The Copyright Transfer Agreement requiring signatures will be e-mailed from the Editorial Office. For information on Uniform Requirements for Manuscripts Submitted to Biomedical Journals, please refer to www.icmje.org.

Abstracts. Please provide an abstract of not more than 150 words.

Byline. Add each author's full name and any advanced degree(s); limit advanced degrees to two. Include each author's affiliation information. Do not include biographical information or detailed information on the authors' company/organization. Be sure full contact information is given for the author who will be the corresponding author; you may include a LinkedIn address, Twitter handle, and website URL.

Headshot. Please provide a publication-quality headshot of all authors.

Key Words. Six to eight key words must be added to the end of the abstract; these will help us index the article and will be published with the abstract.

Call-Outs. List separately four to six direct quotes or concise salient points that merit emphasis. These will be used throughout the text as "call-outs."

Tables. Tables should be numbered and titled, and all tables must be cited in numerical order in the manuscript. Spell out any abbreviations used in a table in the table's footnote section, and use AMA style for any footnote symbols. Tables must be included as editable components of the manuscript file and placed at the end of the manuscript.

Figures. All figures must be numbered and have figure legends. All figures must be cited in numerical order in the manuscript. Figures (e.g., charts, graphs, screenshots) must be submitted as files that are separate from the manuscript text file and should be submitted in their editable native format (e.g., PowerPoint, Excel). Also include a JPG or PDF version of each figure.

Footnotes. Do not use footnotes for text. All text must appear in the body of the manuscript.

Permission. Obtain written permission from the copyright holder (usually the Publisher) to reproduce previously published material. All letters of permission must accompany the manuscript upon submission.

References. References in the text must be footnoted numerically in order as cited in the manuscript, preferably at the end of the sentence. The reference list must appear at the end of the text. Do not use automatic footnote or endnote programs or embedded footnotes. References should follow AMA style as much as possible and include DOIs when available. The following are samples:

(*Note that simply supplying a URL is not a full reference. The name of the Web page along with the name(s) of the author(s) if available and the name of the organization must be provided.*)

Legal Citations. Legal citations can be placed parenthetically in the text; do not use footnotes or list them as references. These should conform to the style adopted by *The Bluebook: A Uniform System of Citation,* published by the Harvard Law Review Association.

Proofs and Reprints. Authors will receive page proofs via e-mail from the copy editor before publication. Order forms for reprints will be sent to the corresponding author. Upon publication, authors will receive a complimentary copy of the issue in which their article appears.
