

PET TRAVEL CHECKLIST

AMSTERDAM – NEWCASTLE ROUTES



All pets must hold a valid European Pet passport or a Health Certificate which should be issued 10 days before travel. If you travel with your pet from the UK to Europe you will need a Health Certificate. For pets travelling from the EU to the UK, the EU Pet Passport will still be accepted.

III. MARKING OF ANIMAL

1. Transponder alphanumeric code
2. Date of application or reading* of the transponder
3. Location of the transponder
4. Tattoo alphanumeric code
5. Date of application/date of reading of the tattoo

The marking must be verified before any new entry is made on this passport

A pet must be microchipped. Chip number and implantation date must be recorded on travel documentation by a vet. Microchipping must happen before or on the same day as the first rabies vaccination. Please make sure to travel with your pet's previous passport if your pet holds a new one and the microchipping date in the new passport is reported as being a reading date. The order of preparation might not be valid if no booster vaccination follows the reading date.

A pet must be vaccinated against rabies with a signed and dated veterinary certificate. Your pet cannot enter the UK until 21 days after the first vaccination (vaccination date = day 0). Subsequent entries to the UK do not require a waiting period if all rabies vaccinations are up to date and recorded. If the booster vaccination has not been administered by the 'valid until' date, a new waiting period of 21 days will be necessary.

V. IN CASE OF A FURTHER TEST

I, the undersigned, confirm that I have seen an official record stating that a rabies antibody titration test performed at an EU-approved laboratory on a sample of blood collected on the date mentioned below from the above described animal proved a response to anti-rabies vaccination at a level of serum neutralising antibody equal to or greater than 0.5 IU/ml.

Blood tests are no longer required if you are entering the UK from EU and listed Non-EU countries. If travelling from an unlisted country, a blood test must be performed a month after the rabies vaccination. Visit www.gov.uk/take-pet-abroad/pet-passport for more information.

VI. RABIES ANTIBODY TITRATION TEST

For dogs only: A tapeworm treatment must be administered by a vet no less than 24 hours and no more than 120 hours before entering to the UK. The treatment date and time must be reported on the passport. Please note that the product's name must be recorded on the travel document and must contain prazicantel to comply with the Pet travel scheme.
