

COMPETITION RULES (As amended on 02/07/2021)

JUNG S.A.S., a Société par Actions Simplifiée, registered with the Paris Trade and Companies Register under number 804 049 476, having its registered office in Paris at 154 Boulevard Macdonald, 75019 Paris (the ""Organiser"") is organising a game with no obligation to purchase (the ""Game"") from 03/06/2021 to 30/06/2021. The Game will take place on the backmarket.co.uk website (""the Site"").

Amendment as of 02/07/2021: The Game has been extended until 12/07/2021.

ARTICLE 1. Terms and Conditions of participation

Participation in the Competition implies full acceptance of these Competition Rules (the ""Rules""). The Competition is open to adults residing within the United Kingdom, the Republic of Ireland, France, Belgium, Germany, Austria, Spain, Italy, Portugal, the Netherlands, or Finland (the ""Participants"") and there is no purchase necessary to enter. Excluded from the Competition are (i) the employees of the Organiser and (ii) any person having a direct or indirect link with the Organiser. The Organiser reserves the right to ask any participant to justify that they meet these conditions. In order to participate, the Participant will have to enter his/her email address on the event page, from one of the promotional banners. The Organiser reserves the right to exclude any participants for incomplete, erroneous or illegible identification or entries, intentional or not, or entries carried out in a manner other than that provided in the Rules. Only one entry per person into the Competition is accepted (same email address, and / or same IP address). Any attempt to submit multiple entries will result in permanent exclusion from the Competition.

ARTICLE 2. Prize(s)

Only one (1) Participant will be selected to win the Competition: the prize for the winner: one (1) refurbished iPhone 11 with a maximum value of £700 TTC and one (1) Philips LED Television with a maximum value of £600 TTC. The Winner agrees to accept the prize as proposed and it will not be possible to exchange the prize for cash, other goods or services of any other kind, nor will it be possible to transfer the prize to a third person.

ARTICLE 3. Selection and announcement of the winner

Only one (1) winner will be chosen by a random draw from all the Participants who meet the conditions of participation. This random draw will be organised by the Organiser on the 01/07/2021. The Organiser will contact the winner by email requesting the information necessary for the delivery

of the prize. If the Organiser receives no response from the selected winner and does not receive the full information required within fifteen (15) calendar days, a new winner will be selected by the Organiser and the initial winner will be deemed to have forfeited the prize. After three unsuccessful contacts of winners, the Organizer reserves the right not to distribute the Prize.

ARTICLE 4: Responsibility

The Organiser cannot be held responsible if, for a reason beyond its control, any technical or IT malfunctions impact the smooth running of the Competition. In any event, the Organiser's liability is strictly limited to the delivery of the prize effectively and validly won.

ARTICLE 5: Intellectual property

In accordance with the laws governing literary and artistic property rights, the reproduction and representation by a Participant of all or part of the elements making up this Competition are strictly prohibited.

ARTICLE 6: Personal data
