

# GENERAL RULES OF THE GAME



JUNG S.A.S., a simplified joint stock company, registered in the Paris Trade and Companies Register under number 804 049 476, having its registered office at 199 rue Championnet, 75018 Paris, FRANCE ("Back Market"), is organizing a game without any obligation to purchase (the "Game"). The Game will take place on the official Back Market Website, [www.backmarket.co.uk](http://www.backmarket.co.uk) (the "Website").

Participation in the Game is subject to compliance with the conventions described in the Rules below.

Back Market shall hereinafter be referred to as "the Organizer." The participant will be referred to as the "Participant." The competition's winner is hereinafter referred to as "the Winner."

## ARTICLE 1: Participants to

This Game, without an obligation to purchase, is open to people who are at least 18 years old as of the date of entry and residing in the United Kingdom on the date the Game begins.

Members of the Organizer's staff or any person having a direct or indirect link with the company are excluded from the Game.

The Organizer reserves the right to ask any Participant to justify the above conditions.

## ARTICLE 2: Terms and conditions of the Game

- Be a resident in Great Britain

The Organizer shall have no liability for a Winner's failure to receive notices due to Winner's spam, junk email, non-working Instagram account, or other security settings or for the Winner's provision of incorrect or otherwise non-functioning contact information.
