

District Race Malaysia (18 October – 7 November 2021)

Terms and Conditions:

1. District Race Malaysia ["Contest"] is organized by District Technologies Pte. Ltd. ["Organizer"]. The Contest will be held commencing from 18th October 2021 00:00 (GMT+8) and ends 23:59 (GMT+8) on 7th November 2021 ["Contest Period"]. The Contest is open to anyone over the age of 16 in Malaysia ["Participant"].

2c. Most number of run challenges - The individual with the most run challenge attempts over 1000 points

2ci. The winner will receive a Garmin Forerunner 645

2cii. Participants are only eligible for prizes in one competition. If a participant is the winner of the Lucky Draw competition, they will be excluded from the other competitions and the prize will go to the next participant on the leaderboard.

2d. Employees of District, and their immediate family members are not eligible for the prizes.
