We wanted to share with you some exciting projects and updates that the Board of Directors has been working on.

Projects:

We are pleased to announce that the final phase of the asphalt crack fill repairs throughout the community has been completed. We are now scheduling the street slurry project for this coming summer to extend the lifespan of the asphalt. We will send out a notice including dates and times of street closures, along with the community map soon. This project was a more cost-effective solution than complete removal and replacement of the streets. The HOA will reassess the condition of the streets over the next 2-3 years to determine if future removal and replacement of asphalt can be done in phases. We are grateful for your cooperation during the street work project.

Updates:

We have received several reports from homeowners regarding speeding within the community. To address this, we are considering installing speed bumps in high-traffic areas where residents are more likely to speed. We would love to hear your thoughts on this proposed project. - Please drive carefully and adhere to the 15 miles per hour speed limit, especially when entering and exiting the community. Let's make sure everyone feels safe while on the road.

- Please take the time to look around the exterior of your home for any needed maintenance, repairs, power washing stucco and roofs, as well as keeping up with the landscaping of your property. We all want to see our neighborhood looking well-maintained and keep our property values up.
- We urge all residents to be mindful of children playing in the streets. With summer around the corner, please ensure your children are careful and attentive while riding bikes, skateboards, and playing sports in the community. Please do not block traffic or vehicles right of way with children's play equipment, bounce houses, or easy ups. These items should be kept on the resident's private property.
