

### **PURPOSE OF GUIDE**

The purpose of this guide is to help caravan, campsite and holiday park owners raise awareness of the importance of recycling amongst staff and visitors and encourage the correct separation and collection of waste materials for recycling.

## WORKPLACE RECYCLING LAW

The law requires all workplaces, including caravan, campsite and holiday parks, to present the following recyclable materials for collection, separately from general, non-recyclable waste:

- Food waste;
- Glass bottles and jars;
- Metals, plastics and cartons these materials can be mixed in the same container: and
- Cardboard and paper these materials can be mixed in the same container.

#### **Code of Practice**

Welsh Government has established a **Code of Practice** for the separation of waste as part of its efforts to increase recycling across the country. This code sets out specific requirements for how to comply with the law and ensure waste is separated at source to facilitate increased recycling and ensure high-quality materials are collected.

#### **Business of Recycling Wales**

Wales is currently second in the world when it comes to recycling waste from households. The current recycling rate from households is just over 65% and helps prevent around 400,000 tonnes of carbon emissions each year. The aim is to build on the success of household recycling and ensure high recycling rates across workplaces too, including caravan, campsite and holiday parks.

To help organisations understand and navigate the regulations, WRAP Cymru has developed the new **Business of Recycling Wales website**. This provides guidance and free downloadable resources to help organisations start or improve recycling in the workplace. This includes specific guidance for caravan, campsite and holiday parks.

#### **Wales Recycles**

<u>Wales Recycles</u> is the national recycling campaign for Wales. Supported and funded by Welsh Government, and adopted locally by councils and other partners, the campaign aims to encourage citizens to recycle more things more often from around the home.

As the communication activities at caravan, campsite and holiday parks are predominantly consumer facing, the recognised Wales Recycles branding has been used for the communication assets, to build on existing tried and tested materials.



## BENEFITS OF RECYCLING

Separating recyclable materials helps improve the quality and quantity of materials collected.

This helps increase recycling rates and will help Wales become the number 1 recycling nation in the world!

It reduces waste sent to landfills and incineration.

This will make an important contribution to reducing carbon emissions.

It supports the circular economy.

By increasing the amount and quality of recycled materials that can then be used by Welsh manufacturers and reduce the use of virgin materials.

### **USING YOUR WEBSITE**

In addition to the supporting communication assets, we've made available to caravan. campsite and holiday park owners, we advise you use the existing communications outlets and platforms you manage every day, to inform visitors of your recycling facilities and how they should be used. These include your website, social media, booking confirmation notifications and emails, and internal briefings with staff and collection contractors.

#### Website

Providing a summary of information about your recycling practices can be a useful way to provide visitors with essential information about what can be recycled. You may even want to develop a dedicated webpage about your recycling facilities and promote this by creating a specific link to this page, for example,

www.campsite.org.uk/recycling, to signpost visitors directly to this information.

Alternatively, you may have an existing webpage with information about your environmental or sustainability credentials and could add recycling information for your site(s) to this.

#### **Example website page content**

#### **Recycling and waste management**

We're committed to protecting our local environment and minimising our impact on resources for the benefit of all. Wales is currently number 2 in the world for recycling; let's aim for number one!

#### We provide dedicated recycling bins for:

- Food waste, including leftovers and any waste generated from preparing food.
- Glass, such as drinks bottles and food jars.
- Cardboard and paper, such as old newspapers, magazines and packaging.
- Metal cans, tins, empty aerosols and clean foil.
- Plastic bottles, pots, tubs and trays.
- Food and drink cartons, such as Tetra Pak, and coffee cups.

Visitors simply need to keep their recycling separate from their nonrecyclable waste, then put the loose items into the correct bins, which are clearly marked and located in dedicated areas across the site.

Please don't put plastic bags and wrapping in the bin for mixed metals, plastics and cartons as this cannot be recycled. Some of these items are accepted at 'out-of-home' recycling points at locations such as supermarkets. Visit walesrecycles.org.uk to find your nearest facility. If you're unable to take these items to one of these facilities and you need to dispose of these on the site, please put them in the bin for non-recyclable waste.

If you're unsure of where something goes, ask one of our friendly staff members when you arrive at the site.

#### Why recycle?

# SUPPORTING COMMUNICATION ASSETS

We've developed free downloadable communication assets to help promote the recycling facilities at your site.

**Welcome flyer** – to share with staff and visitors, with instructions about what can be recycled, how and where on the site. This can be printed or shared electronically.

**Instructional poster** – to reinforce what items of waste should be separated and recycled. This can be displayed in washing-up areas, site receptions, cafes, next to recycling bins, etc.

**Container signage posters** – to be applied to recycling bins to ensure they're clearly labelled and reinforce what can be recycled in each one.
